**Ed.D. in Education  
Option: Occupational and Adult Education**

*“Cultivating Intellectual Capital”*

The Ed.D. degree in Education with a focus on Occupational and Adult Education is intended for individuals seeking employment as scholar-practitioners. The Ed.D. focuses on translating theory and research into practice, and has the larger goal of preparing scholar-practitioners who will be well-informed, credible leaders in the field of adult, occupational, and continuing education. An Ed.D. recipient in Occupational and Adult Education is prepared for leadership careers related to education and change at the individual, group, organization, community, and societal levels, in a variety of settings (educational—formal and informal, second-chance adult basic education, health care organizations, non-profit, social profit, government, corporate, learning communities, continuing professional education and training, occupational and vocational education, and special programs for adults in post-secondary education), as well as in the following practice domains of adult education: adult teaching and learning, curriculum and instructional design and development, program planning and administration, or curriculum and/or program evaluation.

Ed.D. recipients in Occupational and Adult Education analyze the nature, function and scope of adult, occupational and continuing education; value the concept of informed and reflective practice; integrate disciplinary knowledge with theories of teaching and learning; reconceptualize the meaning and value of teaching and learning; conduct informed scholarly practice, evaluation, and organizational development using various methodologies of inquiry; and become responsible stewards of the discipline and culture of lifelong learning. The purpose is to develop scholar-practitioners who can utilize theory and research to enhance their capacity to bridge theory and practice as well as contribute to knowledge in the field.

**PROGRAM REQUIREMENTS**

The Occupational and Adult Education curriculum was designed to provide the knowledge, skills and experiences necessary for understanding the nature, function and scope of adult education both inside and outside of formal adult educational settings. Students plan their programs in consultation with their advisor and dissertation committees. The total number of hours required for the degree is 90 hours beyond the bachelor's degree, 30 hours of which may be approved from a master's degree or post-master's coursework, and all hours listed are required minimums. Students may take additional hours and some courses of study may require more than the 90-hour minimum as directed by the student's advisor and committee.

Students proceed through their respective degree programs with the assistance and guidance of a faculty advisor and an advisory committee. The student develops a plan of study, completes a qualifying examination process, submits a dissertation proposal, and completes a dissertation following the procedures outlined by the Graduate School, the Education Doctoral Programs faculty, and the student's advisory committee. The degree plan has the following course components:

**EDUCATION DOCTORAL PROGRAMS CORE:** (minimum of 15 credit hours)

Students in both Education degree programs, regardless of the option area, complete core courses that situate teaching and learning within social, cultural, historical, and economic contexts. Each course is taught

collaboratively across degree programs and options to address issues related to higher education and adult learners in the belief that such knowledge is equally applicable regardless of one's career path.

**DISCIPLINED INQUIRY CORE:** (minimum of 15 credit hours)

*Note:* EDUC 702: Statistics in Educational Research (3 credits) is a prerequisite for some research courses but does not count toward the completion of your doctoral degree should you need to complete it.

All students in the Ed.D. program with an option in Occupational and Adult Education are required to take the following fifteen (15) credit hours of disciplined inquiry courses.

**OCCUPATIONAL AND ADULT EDUCATION OPTION:** (minimum of 21 credit hours)

Students in the Ed.D. program with an option in Occupational and Adult Education complete core courses that provide a foundation for the field. These courses will prepare students to take the role of designer and facilitator in a variety of adult learning environments. Each course is taught collaboratively across degree programs to address issues related to occupational and adult education in the belief that such knowledge is equally applicable regardless of one's career path.

**INDEPENDENT RESEARCH:** (minimum of 12 credit hours)

Students in the Ed.D. program in with an option in Occupational and Adult Education complete an original research project in the form of a doctoral dissertation. This dissertation should seek to advance knowledge through the application of theory related to the field of Occupational and Adult Education. An Ed.D.

dissertation is more application oriented and aims to design a project that utilizes current research to inform practice and create a bridge between theory and practice, as well as contribute to knowledge in the field. The student's advisor and committee will support and mentor students through this process.

Upon successful completion of the comprehensive examination process, students are required to complete at least twelve (12) hours of independent dissertation research.
