A Message from Rich Bagger, Chairman, Celgene PAC

I am pleased to share Celgene's political contributions report for the second half of 2014, which includes a listing of candidates and political committees supported by either the Celgene Corporation Political Action Committee (Celgene PAC) or Celgene Corporation during the period from July 1 through December 31 of 2014.

During the second half of 2014 the Celgene PAC made contributions totaling \$90,000 to 69 candidates and 16 political committees from both political parties at the Federal and State levels. Contributions from Celgene Corporation during that period in states where corporate contributions are permitted totaled \$38,500 to 59 candidates from both political parties.

During the second half of 2014, the Celgene PAC made the largest number of contributions during any half year period since its founding two and a half years ago. This builds upon a very successful first half of 2014, where the number of contributions increased significant year-over-year as well. This is a testament to the continued support of Celgene PAC members throughout the company.

I hope you will take a few moments to review this report and see which candidates the Celgene PAC supported in your state.

The Celgene PAC is a volunteer, nonpartisan, employee-run organization that provides opportunities for eligible employees to participate in the American political process. The Celgene PAC supports and contributes to candidates from both political parties who share our commitment to these core principles of access and innovation in health care:

- Expanding access to medicines through a competitive marketplace and a regulatory environment in which innovation can flourish
- Protecting the patient-physician relationship and ensuring patient access to innovative treatments
- Recognizing the important role of biopharmaceutical companies and their employees in the ecosystem of innovation in health care

The Celgene PAC Board of Directors, which is comprised of Celgene employees, meets monthly to consider recommendations for PAC support and approve all contributions to candidates and political committees. The Celgene PAC Board also reviews and approves any political contributions made by Celgene Corporation in states and to entities where contributions with corporate funds are permitted.

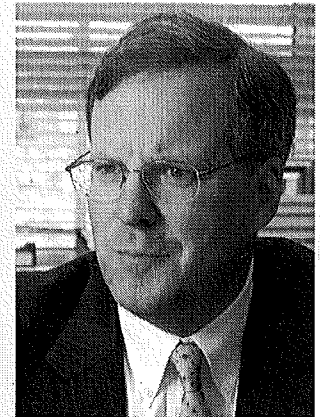

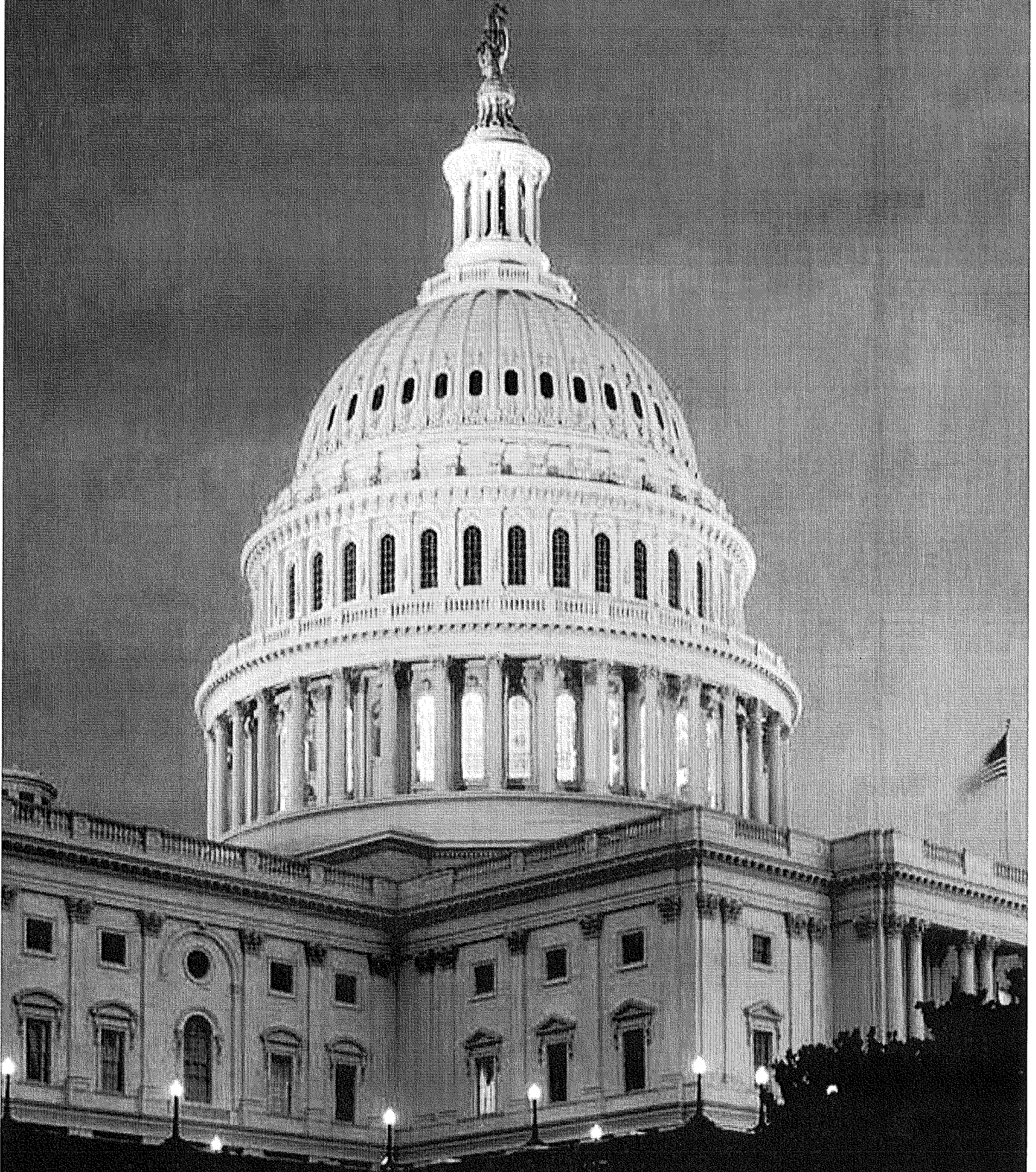

Lilly and Political Financial Support



Government actions such as price controls, importation, and access restrictions impact availability of medicines to patients and Lilly's ability to invest in innovation. Lilly maintains a comprehensive government relations operation to monitor and influence the public policy-making process at both the state and federal levels.

Eli Lilly and Company is committed to participating in the political process as a responsible corporate citizen to help inform the debate in the United States over healthcare and pharmaceutical innovation. As a company that operates in a highly competitive and regulated industry, Lilly must participate in the political process in order to fulfill its fiduciary responsibility to its shareholders, and its responsibilities to its customers and its employees.

Corporate Political Contributions

Elected officials, no matter what level, have an impact on public policy issues affecting Lilly. Lilly is committed to backing candidates of any party who support public policies that contribute to pharmaceutical innovation and healthy patients. A number of factors are considered when reviewing candidates for support. The following evaluation criteria are used to allocate corporate contributions:

- Has the candidate historically voted or announced positions on issues of importance to Lilly, such as pharmaceutical innovation and healthcare?
- Has the candidate demonstrated leadership on key committees of importance to our business?
- Does the candidate demonstrate potential for legislative leadership?
- Is the candidate dedicated to improving the relationship between business and government?
- Does the candidate represent a

state or district where Lilly operates a facility or has a large concentration of employees or retirees?

- Would Lilly support have an impact on his or her campaign?

It is against company policy for any company funds, property, or employee services to be used or authorized to support any candidate for political office, political party, official, or committee unless the support is permitted by law and approved by the appropriate company representatives.

Lilly corporate political donations are made in accordance with a budget for company political contributions. This budget is determined annually and allocated by state. Throughout the year, members of the company's government affairs organization bring forward specific recommendations for company political contributions. The Chief Financial Officer and General Counsel of the company must approve U.S. corporate political contributions before they are made. The government affairs group manages the process for delivery of contributions so approved.

LillyPAC Contributions

In addition to corporate political contributions, Lilly also enables voluntary eligible employee participation by sponsoring a Political Action Committee, the LillyPAC. The LillyPAC Governing Board (the Board) oversees all donations made by the LillyPAC. The Board is comprised of 13 U.S.-based employees who represent components throughout the company.

2010 Report of Political Financial Support

LillyPAC donations are made in accordance with a budget, which is determined annually by the Board.

The Board utilizes the same corporate contribution criteria outlined above for determining LillyPAC contributions. LillyPAC support is divided between federal and state candidates. Throughout the year, members of the company's government affairs organization and employee LillyPAC members may bring forward specific recommendations for LillyPAC contributions. LillyPAC contributions are not required to be approved separately by the Chief Financial Officer or General Counsel of Lilly.

The LillyPAC is funded by contributions from eligible employees. All disclosure requirements are met that apply to the LillyPAC. LillyPAC contribution data are available to the public on the Federal Election Committee (FEC) website and through the individual states' agencies.

Memberships

In addition to direct political contributions, Eli Lilly and Company also maintains memberships in organizations that report lobbying activity to the U.S. federal government. Lilly is committed to supporting these organizations who champion public policies that contribute to pharmaceutical innovation and healthy patients. Below is a list of organizations to which Lilly contributes \$50,000 per year or more. Organizations where the company has a board seat are noted to reflect the greater degree of involvement in setting priorities for those organizations.
