Graduate Faculty Meeting Notes April 19, 2006 FLC 320

Dr. Wittrock called the meeting to order at 3:30 pm.

The floor was opened to additional nominations for Graduate Council elections. Dr. William Berzonsky from Plant Sciences was added to the ballot. Votes will be tabulated and winner announced by Dr. Wittrock via the faculty listserv.

#### **Thesis Alternative Policy**

Dr. Wittrock presented the new Thesis Alternative Policy developed by the Graduate Council. It was recommended that in the last line of the first paragraph, the terms "typically" and "only" be deleted and "well-defined be added before experience. There was discussion the rigor of the student experience under all three options and the purpose of a committee when there is no thesis. The adoption of the Thesis Alternative Policy was passed by the faculty present.

#### **Continuous Enrollment**

Dr. Wittrock presented the Continuous Enrollment policy that was revised by the Graduate Council. He pointed out after fall semester students must be registered continuously until they hand in the final copies of their disquisition. Dr. Wittrock also clarified students who disappear without requesting a leave of absence must register for one credit for each semester missed up to four semesters (fall & spring). A student who has been gone for more than two years must reapply *and*, if accepted, register for four credits. There was discussion about summer semester.

#### **Graduate Assistant Policy**

Dr. Wittrock presented the new Graduate Assistant Policy developed by the Graduate Council. It was recommended to include under the Eligibility section Graduate Administrative Assistants to the sentence about tuition waivers. The Graduate Assistant Policy was passed by the faculty present.

# North Dakota State University Graduate Faculty Meeting April 25, 2002

Dean Velmer Burton called the NDSU Annual Graduate Faculty Meeting to order at 11 a.m. on April 25, 2002, in the University Chambers, Memorial Union.

The minutes of the previous meeting were distributed. Ron Stammen noted that the Family Financial Planning was approved as a new option in the Child Development and Family Science Department - - not the School of Education. Stammen moved the minutes be approved as corrected. It was seconded. Motion carried.

Burton commented on The Graduate School mentioning that applications are up 50% and acceptances have doubled. He said he was looking at revamping the method of handling applications. Additionally, qualified students refused in one department are sent to related departments for possible placement.

Burton thanked David Wittrock and John Martin for their hard work in the Graduate Council over the past three years. The floor was opened for nominations. Nominated for positions on the Graduate Council were Jorge Calvo, David Haney and Lynn Rust. Kirk Howatt moved that nominations cease. It was seconded. Motion carried. An election by ballot was held. The new Graduate Council members are Jorge Calvo and Lynn Rust.

Burton provided an overview of the PhD, Masters and Certificate programs approved by the Graduate Council this past year. He said there will be 75 doctoral stipends for this coming year all for recruitment enhancement for PhD programs. This fiscal year, \$260,000 has been allocated for stipend enhancements and opposed to \$34,000 two years ago. A capital campaign is being created by provide \$16 million for Presidential Scholarships.

Will Bleier asked for suggestions in dealing with the wide range of graduate stipends in a single department, Sanku Mallik asked about the possibility of interactive applications. Burton said UND and NDSU could not agree on a common application and the cost is prohibitive. Burton also mentioned that the application fee for Graduate School will rise to \$35 on July 1, 2002.

It was motioned to adjourn. Seconded and carried.

#### **GRADUATE FACULTY MEETING**

The Graduate Faculty meeting convened at 3:30 p.m. on Wednesday, 19 April 2000, in the Peace Garden Room, Memorial Union.

The Minutes of the 29 April 1999 Graduate Faculty meeting were received by the faculty as written.

Nominations for Graduate Council members were received from the floor, and A. Grazul-Bilska and J. Hershberger were elected to serve 3-year terms on the Graduate Council. Interim Dean Slanger will appoint (2) additional graduate faculty to complete the 12-member Graduate Council for the 2000-2001 academic year.

Discussion focused on the *Graduate Certificate Programs at NDSU*. It was noted that graduate certificate programs, at the national level, have been implemented in response to the demand for additional training in the business world and a request for life-long learning opportunities in the general public. At NDSU, the graduate certificate programs will be comprised of courses already offered by the faculty and will not consist of new courses created only for the graduate certificate program. A graduate certificate will not be awarded after an accumulation of courses, but rather after completion of a prescribed program of study. It was explained that the transfer of credits from the degree program to a graduate certificate program had been limited to 4 credits to encourage the completion of a degree, while the transfer of 8 credits from a graduate certificate program to a degree program would encourage moving to a graduate degree. Graduate Faculty approved (34 yes, 10 no) the policy, *Graduate Certificate Programs at NDSU*, after deleting the language addressing the transfer of credits from a graduate certificate program to a graduate degree and from a graduate degree to a graduate certificate program.

The Graduate Faculty also discussed the *Definition of Graduate Faculty*, centering on the definition of Associate Members and their defined responsibilities. It was noted the adjunct faculty are often as interested in graduate education as graduate faculty and should, therefore, be qualified to serve as chairs of graduate committees. It was suggested that the responsibility of deciding the status and responsibilities of adjunct members should remain within the individual departments. The *Definition of Graduate Faculty* was approved (22 yes, 18 no) with the amendment that "Associate Members of the Graduate Faculty of NDSU with courtesy appointments at NDSU who are full-time employees of on-campus units and whose position responsibilities involve primarily scholarly activity may serve as co-chairs chairs...." A motion was made, seconded, and passed to reconsider the motion that had just passed. A motion was passed (31 yes, 5 no) to amend the first sentence of the paragraph on associate membership of Section 3 to the following (changes in boldface):

"An Associate Member of the Graduate Faculty of NDSU with a courtesy appointment (adjunct) at NDSU who is a full-time employee of **either** an on-campus unit **or a Research and Extension** Center and whose position responsibilities involve primarily scholar activity may serve as a chair of supervisory and advisory committees." The second and final sentence of this paragraph is "All Associate Members of the Graduate Faculty at NDSU may teach graduate courses and serve as members of supervisory and advisory committees."

The meeting adjourned at 5:05 p.m.

## North Dakota State University Graduate Faculty Meeting April 27, 2001

Dean Velmer Burton called The Graduate Faculty meeting to order on April 27th, 2001, at 3 p.m. in the NDSU Alumni Center.

The minutes of the April 19<sup>th</sup>, 2000, Graduate Faculty Meeting were distributed. It was moved and seconded to approve the minutes. Motion carried.

Nominations for members of the Graduate Council were received from the floor. Suranjan Panigrahi and Kirk Howatt were unanimously elected to serve.

#### DISCUSSION:

Dean Burton discussed the idea of creating by-laws for the Graduate Faculty.

Burton gave an overview of the past year's activities:

The Educational Credential Evaluators (ECE) transcript review for applicants was eliminated last Fall. The Graduate School currently evaluates international transcripts using the same conversion tables as the ECE evaluators.

Three PhD programs were approved at the May 7<sup>th</sup> University Senate meeting: Criminal Justice, Molecular Pathogenesis and Human Development. One new Masters program has been approved: the Nursing Masters through the Tri-College. Family Financial Planning was approved as a new option in the School of Education. NDSU had 24 students enroll in its first year.

Discussion followed concerning what the new PhD programs require in regard to university resources. The idea of an Open Forum was raised. Kathleen Slobin indicated that there will be a University Senate Open Forum in the Fall to discuss the PhD goals.

Burton explained that Forms 100 and 101 for graduate assistantships were now being routed through The Graduate School. The Graduate School database, which includes all new applications, was made available to all graduate departments last Fall.

Burton talked about the implementation of the new Graduate School webpage. Discussions are ongoing regarding online applications.

The Dean explained the consortiums that Psychology and Mathematics have sponsored. The idea has been well-received and new year a consortium will focus on the College of Agriculture.

Graduate enrollment is up, but the head counts don't reflect the total graduate school population. Students will be strongly urged to register by the third week of classes so they are included in the graduate student head count.

The Disquisition Editor is reading about 120 papers a year. Two readers have been hired and they are reading about 30-40 per year. General discussion followed concerning timelines, committees and advisors.

The meeting was adjourned.
