III. Composition of the Senate

- A. Staff Senate will be comprised of up to sixty elected members representing the broadband classifications: 1000 Executive/Administrative/Management and 3000 Professional (combined), 4000 Technical, 5000 Office, and 6000 Crafts/Trades and 7000 Service (combined). Membership is based on fifty members representing broadband classifications and ten at-large members elected from any classification. The fifty broadbanded members are determined by the percentage of each classification as compared to the total number of NDSU broadbanded employees. Representation of each band is to be reviewed annually prior to the annual election.
- B. The ten members at large will be selected from the remaining candidates who did not fill a banded vacancy. The top ten candidates receiving the highest amount of votes during the general election will be selected as the members at large.
- C. Executive officers shall be elected from the membership of Staff Senate.
- D. The Executive Committee will consist of the President, Vice President/President Elect, Past President, Secretary, Treasurer, Membership/Attendance Officer, Public Relations Officer, <u>Information Technology Officer</u>, and three Members-at-Large.
- E. The Director of Human Resources or the director's designated representative shall serve in an ex-officio capacity on the Staff Senate and Executive Committee.

Legislative Report

HB 1087 requiring 60% success rate on civics test before high school graduation passed through the House and Senate and has been signed into law by the governor.

HB 1195 permitting concealed weapon by a licensed individual on school property, with approval of the governing board has passed through the House.

HB 1246 requiring compensation comparisons for classified state employees to include at least 50% of health insurance and retirement contributions has passed through the House.

HB 1303 shifting tuition and fee setting authority from SBHE to legislature has passed through the House.

SB 2165 requiring BND to set aside \$5,000 for each child born to ND residents to be used for college or BND student loan debt; and if not college expenses, used for nursing home care. Anyone rec'd \$5,000 would be ineligible for AC/CTE scholarship.

Other Notes:

SBHE chair Kirsten Diederich has resigned and Terry Hjelmstad has been named interim chair. A search is already underway for a permanent chair.

Pres. Cabinet

Wednesday, January 14, 2015

The President called a special cabinet meeting to address the resignation of Dr. Kirsten Diedrich. A full search will eventually take place to replace her. As for the process to approve SBHE members, the senate review is a recommendation, but the votes goes to the legislature.

The President also talked about the legislative process. He felt there are some concerns about lower oil prices. He also stated, for the most part, the governor's budget is being supported. This is good for higher education.

He talked about upcoming bills. Many bills are written and most do not go through. We should be aware of proposed bills, but continue to watch their progress. New software to follow bills has been developed.

Pres. Cabinet January 26, 2015

President has been involved in the legislative session. Discussion was held on the Sanford/NDSU Nursing Program. Dr. Bresciani brought in several experts to speak. The committee had very few questions. Good news for the program.

The Student Government legislative lobbyists are Aaron Weber and Megan Matajcek. They are described as "studied and articulate". NDSU student leadership is the class of the session. They have been looked to as a resource from many, including the governor.

More support is being given to NDSU capital expenses such as Dunbar, Sudro and Engineering. Dunbar is a life-safety issue while accreditation concerns rest with Sudro and Engineering. The president feels there has been a "warming" to the need and there is still hope for funding. The age of several buildings on campus is between 50-75 years. Later in the meeting Dr. Rusch emphasized that R2 does not have the room to take all of Dunbar to that building.

Colette Erickson and Brittnee Nikle presented to the cabinet on the Affordable Care Act. A newsletter to supervisors went out this week. Employees who work an average of 30 hours per week or 130 hours a month need to be offered health insurance. This does not apply to other benefits typically tied to fully benefitted employees.

The president reminded all in the cabinet to, again, be very careful during the legislative session. University Relations and the vice presidents can assist with any concerns.

1/27 was NDSU research day at the capitol. NDSU showcased undergraduate research. 8 students and 9 faculty attended.

Matt Larsen: NDSU is tied for 1st for the Capital One Cup. Coach Kleiman's contract was extended 2 years to 2021. Matt and Dr. Bresciani attended the national NCAA meeting. NDSU is known around the country at the NCAA level.

Kelly Rusch: Pigs are being used for advanced trauma life support training. Methods are reviewed every 3 years and NDSU's protocol is approved. A recent article referenced previous audits from 2003-2006. An attending veterinarian has been involved since 2006.

Provost Ingram: Announced Dr. Virginia Clark-Johnson is retiring.

Bruce Bollinger: Ray Boyer is retiring.

Dale Zetocha, Exec. Dir. NDSU Research Foundation: NDSU saw over \$2M in research revenue royalty income.

Marc Wallman: NDSU is hosting the Northern Tier Steering Committee.

Laura McDaniel: noted the new video is out on the website. If appropriate, consider adding it to additional websites.

Sarah Russell: March 9th – ND High School Counselors will be hosted. Bike Share bikes are here and will be available as soon as weather permits.
