Describe the programming to be supported by the grant.

The NDSU School of Music is grateful for the opportunity to apply for support for the 33rd Annual High School Invitational Jazz Festival. This event will be held on the campus of NDSU on Friday, February 7 and Saturday, February 8, 2014.

We are applying for additional support to allow continued growth of the festival's ability to serve the region's schools, and to support continued high quality of our guest artists.

In its recently expanded format (held over two days), the festival will serve approximately 20 invited regional high-school and middle school jazz ensembles (representing about 300 students @ 20 per band)-primarily from North Dakota (Bismarck/Mandan, Minot, Jamestown, Grand Forks, Fargo), but also including bands from South Dakota, Minnesota and Manitoba.

Each band is adjudicated by top professional jazz musicians and educators. The Festival is strictly educational, meaning there are no competitive places awarded-the feedback from the adjudicators is delivered in a manner to help the band and director improve and to better understand the genre performed

Past adjudicators have included bassist Kristin Korb, trumpeter Rex Richardson, trombonist and arranger Eric Richards, saxophonist Chris Vadala and many more.

These young musicians will also have opportunities to attend workshops and performances by the clinicians and the event will culminate in a performance by the NDSU Jazz Ensemble in performance with our guest artists.

This concert is also open to the general public and is well attended by the community in addition to our high school band members.

Dr. Kyle Mack-trombone/low brass/director NDSU Jazz Ensemble

Dr. Jeremy Brekke-trumpet/high brass/director NDSU Lab Bands

Describe the community's involvement with the programming.

Our core community is the jazz band programs from regional middle and high schools. Each invited band chooses its own big band repertoire-big band repertoire is available from a 80 year history of the art form and ranges from traditional swing to rock and funk styles. Programming, guided by each band's director, is dependent on skill level of the musicians in each ensemble, instrumentation, and artistic preference.

The NDSU Festival's role is facilitating the performance of regional jazz bands, interaction of adjudicator and bands, and providing high-quality concert performances for the visiting regional bands/students and community.

Explain the program's anticipated benefit for the community, artists, and applicant.

There are many benefits of a jazz-based Festival. They include:

- Direct contact of regional students with working professional musicians and educators
- Modeling of musical styles (jazz) for young musicians-many of whom do not listen to the art form and may not have heard the music played at a high level

Mission-does the festival serve the land-grant mission of NDSU?

After more than 30 years of experience in producing this festival, we have the perspective of time-we have seen the outcome of excellent middle and high-school jazz education-programs which send high functioning students to the best programs and schools in the region and beyond. Many of these student become the next generation of jazz band directors who, in turn, train the next generation of musicians in our region.

Applications will be reviewed by a panel. The review panel will evaluate each application and make funding recommendations to the NDCA's board based on the following criteria. (All of the panel's recommendations will be subject to board approval.)

- Amount requested and availability of funds.
- Artistic merit:
- 1. Does the activity employ high-quality professional artists?
- 2. Does the activity support the work of or offer opportunities to North Dakota artists?
- Audience/Community development:
- 1. Is the activity designed to expand the audience's knowledge of and appreciation for the arts?
- 2. Will the activity make the arts more visible in the community?
- 3. Are marketing strategies being employed to attract new, larger, and more diverse audiences? If so, describe them. If not, why not?
- Community support:
- 1. Is there evidence of community support such as in-kind contributions, donations, sponsorships, local media coverage, etc.?

He is a member at large of the executive boards of the North Dakota Geographic Alliance and Prairie Division of the Canadian Association of Geographers plus the higher education representative to the North Dakota Education Association and the research universities member of the North Dakota Public Employees Association's board of directors. He has also given several oral presentations and public lectures, or participated as a panelist, at professional/scholarly meetings and other institutions of higher learning. He has conducted workshops and served on prestigious university-wide and departmental committees. He was chairperson of the University of North Dakota Senate in 2006-07. He currently is a faculty representative on the Non-Traditional No More Task Force of the NDUS.

Munski completed his bachelors, master and doctorate degrees at the University of Illinois at Urbana-Champaign. He started his employment at the University of North Dakota in Spring Semester of 1978 and has been there continuously. During this more than three-decade period of teaching, service, research, and administrative duties, he has taught mostly face-to-face courses but also has provided courses statewide through IVN to students mainly at Lake Region State College, Mayville State University, and North Dakota State University but even one semester to undergraduates at United Tribes Technical College in a state-tribal cooperative arrangement. In addition to his current set of oncampus classes, he now provides online courses instead of IVN classes from the Grand Forks campus to collaborative students across the NDUS as well as elsewhere in the United States and beyond, including overseas-based members of the American armed forces. His one-year term expires June 30, 2014.
