- The total population in Grafton has decreased modestly over the past decade as has the overall county population of Walsh.
- Future projections suggest that Walsh County will continue to lose residents.
- Nearly one in every five residents in Grafton and in Walsh County is at least 65 years of age. It is expected
 that by the year 2020, seniors 65 years of age and over will account for nearly 27 percent of the county's
 total population.
- The racial mix of residents in Grafton city and Walsh County remains predominately white. However, over the past decade there has been growth in diversity.

- The total number of housing units in Grafton city and Walsh County has declined slightly during the past decade.
- The housing unit mix in Grafton city and Walsh County mirror larger regional trends with owner-occupied housing accounting for roughly two of three units in Grafton and three of four housing units in Walsh County.
- Nearly half of the vacant housing units in Grafton city are for rent, a proportion more than twice the level for the overall county.
- Migrant housing represents a significant and growing proportion of the vacant housing in Grafton city. It
 currently accounts for more than 11 percent of vacancies, twice the proportion from ten years ago. In
 contrast, the number of vacant migrant housing units in Walsh County has declined over the past decade,
 although the proportion it represents has increased. Nonetheless, it still represents 17 percent of all vacant
 units.
- Seasonal housing vacancies have doubled in both Grafton city and Walsh County over the past decade.
- The median value of an owner-occupied home in Grafton was \$61,400 in 2000 compared to \$52,100 in Walsh County.
- The majority of housing units built in both Grafton city and Walsh County are relatively new with half the homes built after 1960.

- Income levels for Grafton city and Walsh County are relatively the same. Per capita personal income for both was roughly \$16,500 which is 6 percent below the statewide average of \$17,769 and 23 percent below the national average of \$21,587.
- Approximately 12 percent of the residents in Grafton are in poverty, a proportion that has declined over the past decade.
- The number and proportion of children impoverished in Grafton has been cut in half since 1990, dropping from 22.3 percent in 1990 to 11.7 percent in 2000. A similar, but less dramatic decline in elderly poor also occurred during the same time period.

- The number of births in Walsh County continues to decline, dropping from 147 in 2000 to 125 in 2002. For perspective, the number of births in Walsh County 20 years earlier was 268. During the peak of the babyboom period in 1955 there were 465 births in Walsh County.
- The number of deaths occurring in the county continues to rise as the proportion of elderly (residents 65 and over) increases. Not surprisingly, therefore, major contributors to death include heart disease and cancer.

- The labor pool in Grafton has increased modestly over the past 10 years while it has declined in the overall county. As the proportion of youth declines relative to seniors, labor declines are expected to intensify.
- The unemployment rate nearly doubled in Grafton between 1990 and 2000, while it increased slightly in the overall county during the same time period. In 2000, the unemployment rate in Grafton was 10.3 percent, nearly three times higher than the statewide average of 3.0 percent.

Education levels among Grafton residents have increased significantly over the past decade. Only about
one in four residents did not graduate from high school, most of whom are elderly residents. In contrast,
nearly 21 percent of residents have attended college with 10 percent earning a Bachelor's degree. Slightly
more than 3 percent hold a graduate or professional degree.

- Enrollment within the Grafton school district continues to decline reflecting the overall population losses in the county. Between 2000 and 2003, there was nearly a 10 percent drop in total enrollment with the greatest losses occurring in the K-8 grades.
- Although high school graduation rates fluctuate over time due to class size, the overall graduation rate for the school district is quite high.
- Student academic performance scores based on statewide proficiency standards show superior achievement in reading than math. More than half the students in the district were above the cutpoint for reading while roughly one-third were above the cutpoint for math.
