- Both the combined communities of Carson, Elgin, and New Leipzig and Grant County experienced a decline in population between 1990 and 2000.
- Population projections for Grant County indicate that population declines are likely to continue over the next two decades.
- The combined communities of Carson, Elgin, and New Leipzig experienced a slight increase in the proportion of youth under 20 years of age and little change in the proportion of elderly ages 65 and older between 1990 and 2000. Conversely, Grant County experienced a decline in the proportion of youth and an increase in the proportion of elderly. Projections for Grant County indicate that this loss of youth and gain in elderly will likely continue over the next couple decades.
- There was little change in the racial diversity of both the combined communities of Carson, Elgin, and New Leipzig and Grant County between 1990 and 2000; nearly all residents were white.

- Both the combined communities of Carson, Elgin, and New Leipzig and Grant County experienced a decline in the total number of housing units between 1990 and 2000. In 2000, 55 percent of housing units in Grant County and 63 percent in the combined communities were owner-occupied.
- The number of vacant housing units declined in both the combined communities of Carson, Elgin, and New Leipzig and Grant County between 1990 and 2000. In 2000, vacant housing comprised 17 percent of all housing in the combined communities and 31 percent in Grant County.
- In 2000, the median value of an owner-occupied home in the combined communities of Carson, Elgin, and New Leipzig was \$22,833, compared to \$23,500 in Grant County. These 2000 values were actually lower than the 1990 median values after adjusting for inflation.
- In 2000, half of all housing units in the combined communities of Carson, Elgin, and New Leipzig were built before 1963; half of all housing units in Grant County were built before 1961.

- The median household income in the combined communities of Carson, Elgin, and New Leipzig was \$24,211 in 2000, compared to \$23,165 in Grant County. When the 1990 median values are adjusted for inflation, the 2000 median household incomes represent an increase in purchasing power for both the combined communities of Carson, Elgin, and New Leipzig and Grant County.
- The number and proportion of residents living below poverty declined in both the combined communities of Carson, Elgin, and New Leipzig and Grant County between 1990 and 2000. Nonetheless, 15 percent of residents in the combined communities and 20 percent in Grant County were impoverished in 2000.
- The number of both impoverished children and impoverished elderly declined in both the combined communities of Carson, Elgin, and New Leipzig and Grant County between 1990 and 2000. In 2000, children comprised 34 percent of all impoverished residents in Grant County and 25 percent in the combined communities of Carson, Elgin, and New Leipzig. Elderly comprised 24 percent of all impoverished residents in Grant County and 38 percent in the combined communities in 2000.

- Total employment declined for both the combined communities of Carson, Elgin, and New Leipzig and Grant County between 1990 and 2000.
- The percentage of employed that was female increased for both the combined communities of Carson, Elgin, and New Leipzig and Grant County between 1990 and 2000. In 2000, females comprised 49 percent of all employed in the combined communities of Carson, Elgin, and New Leipzig and 45 percent of all employed in Grant County.
- Both the combined communities of Carson, Elgin, and New Leipzig and Grant County experienced growth in manufacturing and service industry employment, and a decline in agricultural employment between 1990 and 2000. In 2000, the service sector was the largest industry in the combined communities, employing 45 percent of all workers. In Grant County, the agriculture and service sectors were the two largest industries in 2000, each employing 34 percent of workers.

- Enrollment within the combined districts of Roosevelt Public School District and Elgin-New Leipzig Public School District declined over the past few years, from 397 students in 2001-2002 to 320 students in 2004-2005.
- In 2004-2005, 65 percent of students in the combined districts of Roosevelt Public School District and Elgin-New Leipzig Public School District were proficient or advanced in reading, up from 57 percent in 2001-2002. In addition, 61 percent of students were proficient or advanced in math in 2004-2005, up from 42 percent in 2001-2002.
