- Both the combined communities of Alexander, Arnegard, and Watford City and McKenzie County experienced a decline in population between 1990 and 2000.
- Population projections for McKenzie County indicate that population declines are likely to continue over the next two decades.
- Both the combined communities of Alexander, Arnegard, and Watford City and McKenzie County experienced a decline in the proportion of residents younger than 20 years of age between 1990 and 2000 and an increase in the proportion of residents ages 65 and older. Population projections for McKenzie County indicate that these trends will likely continue over the next two decades.
- Nearly all residents in the combined communities of Alexander, Arnegard, and Watford City were white in 2000. Nearly one-fifth of residents in McKenzie County were American Indian or Alaska Native.

- Both the combined communities of Alexander, Arnegard, and Watford City and McKenzie County experienced a decline in total housing units between 1990 and 2000. In 2000, 58 percent of housing units in McKenzie County and 56 percent in the combined communities were owner-occupied.
- The combined communities of Alexander, Arnegard, and Watford City and McKenzie County saw a decline in vacant housing units between 1990 and 2000. In 2000, vacant housing comprised 21 percent of all housing in both areas.
- In 2000, the median value of an owner-occupied home in the combined communities of Alexander, Arnegard, and Watford City was \$30,767, compared to \$51,100 in McKenzie County. These 2000 values were actually lower than their 1990 values after adjusting for inflation.
- In 2000, half of all housing units in the combined communities of Alexander, Arnegard, and Watford City were built before 1956; half of all housing units in McKenzie County were built before 1971.

- The median household income in the combined communities of Alexander, Arnegard, and Watford City was \$27,862 in 2000, compared to \$29,342 in McKenzie County. When the 1990 median values are adjusted for inflation, the 2000 median household income represents a decline in purchasing power for McKenzie County, while the combined communities of Alexander Arnegard, and Watford City saw no change in purchasing power.
- Both the combined communities of Alexander, Arnegard, and Watford City and McKenzie County experienced little change in the proportion of persons living below poverty between 1990 and 2000. In 2000, 13 percent of residents in the combined communities and 17 percent in McKenzie County were impoverished.
- The number of both impoverished children and impoverished elderly declined in the combined communities of Alexander, Arnegard, and Watford City between 1990 and 2000. At the same time, the number of impoverished children declined and impoverished elderly increased in McKenzie County. In 2000, children comprised 40 percent of all impoverished residents in McKenzie County and 33 percent in the combined communities of Alexander, Arnegard, and Watford City. In contrast, elderly comprised 11 percent of all impoverished residents in McKenzie County and 22 percent in the combined communities in 2000.

- McKenzie County reported 60 births in 2005, a rate of 10.46 births per 1,000 persons. This rate was down from 12.03 in 2004, but up from 9.41 in 2003.
- The number of deaths occurring in McKenzie county totaled 50 in 2005, down from 71 in 2003. Major contributors to death are heart disease and cancer.
- In 2005, there were six foster care placements in McKenzie County, down from 14 in 2003.

- Total employment declined for both the combined communities of Alexander, Arnegard, and Watford City and McKenzie County between 1990 and 2000.
- Between 1990 and 2000, the proportion of employed that was female increased for both the combined communities of Alexander, Arnegard, and Watford City and McKenzie County. In 2000, females comprised 49 percent of all employed in the combined communities of Alexander, Arnegard, and Watford City and 45 percent in McKenzie County.
- While employment in agriculture, manufacturing, and retail trade declined in both the combined communities of Alexander, Arnegard, and Watford City and McKenzie County between 1990 and 2000, employment in the service industry increased. In 2000, the service sector was the largest industry in both areas, employing 38 percent of workers in McKenzie County and 43 percent in the combined communities.

- The combined districts of Alexander Public School District and McKenzie County Public School District experienced a steady decline in total K-12 enrollment over the past few years. In 2004-2005, 628 students were enrolled, down from 721 in 2001-2002.
- In 2004-2005, 77 percent of students in the combined districts of Alexander Public School District and McKenzie County Public School District were proficient or advanced in reading, up from 64 percent in 2001-2002. In addition, 67 percent of students were proficient or advanced in math in 2004-2005, up from 44 percent in 2001-2002.
