COURSE OVERVIEW:

This course is designed for school counselors, counselor educators, school counseling graduate students, administrators, and district-level staff who oversee or collaborate with school counseling programs. - 4. Identify ways in which school administrators and school counselors can collaborate in order to increase access to student supports.

- A. This paper should be a <u>minimum of four (4) FULL double-spaced typed pages.</u> This one paper will include information for all sessions attended/viewed. Students DO NOT need to write a separate paper for each session.
- B. For EACH session attended/viewed, provide the following information:
 - a. List the title of the session
 - b. An individual summary of the session
 - c. A personal reaction to the session & what you learned by viewing it
 - d. A discussion of how you might apply the information provided in the session to your own work.
