 - iii. One big university budget which started on the Senate, then goes to cross-over, then House, and then committee
 - iv. Budget update out of the Senate, positive things for NDSU out of the Senate budget
 - v. Budget now in the House E&E, positive news coming out of House as well
 - vi. New Horizon concept where is NDSU going over the next 10 years. \$35M ask
 - vii. Funding Formula no adjustments to formula since 2013, specific for NDSU adjustments. There have been adjustments for other institutions and programs
 - a. Requested adjustment to Pharmacy factor, currently ~9, seeking to get closer to Medical factor of 35.
 - b. Averaging adjustment could add \$2.4 million to base
 - c. Challenge Grant funds \$25 million up from \$21 last biennium
 - d. Economic Development research funding \$8 million for all institutions
 - e. \$1 million for high performance computing
 - f. Budget 3% & 3% salary increases

North Dakota United Higher Ed Bills of Interest – 2025 Legislative Session

House Bills (now being heard in the Senate)

HB 1064 – Reciprocity agreements

- Passed in the House 89-1-3
- Would set requirements for out-of-state educational servicers to provide college-level courses in
 ND
- The bill now has an amendment that provides an exemption for some out of state servicers that do not meet CFI score requirements
- SBHE will propose amendments
- Hearing was at 10 am on 3/12 in Senate Education
- Waiting on committee work

HB 1161 – Vacant full-time equivalent position funding pool

- Passed in the House 74-16-3
- Would create a vacant FTE funding pool and require quarterly reporting on higher ed vacancies
- Hearing was at 9 am 3/17/25 in Senate Appropriations E&E
- Waiting on committee work

HB 1220 – Accelerated degrees for high-demand careers

- Passed in the House 73-15-6
- SBHE opposes
- Concern regarding lower-quality degrees/removing general education requirements/licensure not transferring/encroachment of SBHE's authority
- Hearing scheduled at 9 am on Friday, 3/21 in Senate Workforce Development
- NDU members, please submit testimony

HB 1391 – Adds health status as a protected class in discrimination laws

- Passed in the House 67-26-0
- Would make it discriminatory to require vaccines in schools
- Hearing scheduled at 10 am on Tuesday, 3/18 in Senate Industry and Business

HB 1437 – Prohibition of tenure being offered at two-year colleges starting in 2026

- Passed in the House 84-5-5
- Amended to no longer prohibit tenure at two year schools
- Updated bill language is still problematic as it would:
 - Require annual evaluations be conducted by president or designee of president
 - o Require post-tenure review to be conducted by president or designee of president
 - Require post-tenure review committee include supervisor, one ranking administrator and no more than one faculty member
 - Require the SBHE to be involved in the firing of faculty along with the employing institution

- Committee work scheduled at 2:30 on Wednesday, 3/19 in Senate Education

HB 1588 – Possession of firearms in public

- Passed in the House 49-43-1
- Amendments include
 - Ban on binary triggers
 - Ability of a political subdivision to enact and enforce firearm or dangerous weapon prohibition in public areas and buildings
 - o Carve out of higher education that empowers SBHE to enact their own firearm policy
- Waiting on Senate committee hearing date

Senate Bills (now being heard in the house)

SB 2003 - Higher ed funding

- Passed in the Senate 44-2-1
- Legislature allocated 3% and 3% funding increases for each year of the biennium
 - Plus 1% and 1% for increased healthcare costs
- Multiple hearings for each institution within the last two weeks in House Appropriations E&E committee
- Waiting on new hearings and committee work schedule
- Will likely not be finalized until closer to the end of the session

SB 2147 – Student loan repayment program and scholarship program

- Passed in the Senate 41-3-3
- Amends a supplemental student loan financial assistance program for individuals whose total family income is less than \$80k/year
- Recipients are required to:
 - o Reside in ND or within 50 miles of ND upon graduation
 - o Have a student loan with the Bank of North Dakota or another participating lender
- Financial assistance capped at \$17k/year
- Also amends a skilled workforce scholarship program for ND college students
- Students receiving this scholarship must:
 - Maintain a 2.5 GPA or higher
 - Be enrolled in a qualifying educational program
 - Reside and work in ND or within 50 miles of ND
 - Work in an eligible high-demand or emerging occupation for a minimum of three years upon graduation of college program
- A recipient of this scholarship must pay it back if they breach the above requirements

- Committee hearing was 3/13 at 3:30 in House Appropriations E&E
- Committee work scheduled Thursday, 3/20 at 915 am in House Appropriations

SB 2160 – Changes state employee health insurance plan to a non-grandfathered plan with additional healthcare benefits at a cost

- Passed in the Senate 44-2-1
- Requires the state to cover increased health plan costs
- Committee hearing scheduled today, 3/17 at 3:30 pm in House Industry, Business, and Labor

SB 2242 – "Shall consider" study on the feasibility of consolidating higher ed institutions, development of three-year bachelor programs, dual credit expansion, analysis of tuition cost

- Passed in the Senate 47-0
- Passed in the House 89-4-1 after amendments
- Newly amended version includes two additions to the study:
 - Research of the competitiveness among state institutions
 - o An analysis of the quality of education provided at each state institution
- Concurred in the Senate 47-0
- Headed to the Governor to be signed

SB 2307 - Book ban bill framed as "obscenity control"

- Passed in the Senate 27-20
- Requires relocation of material judged as obscene by "reasonable" or "average" adults to a location not easily accessible to minors
- Requires safety policy and prevention measures to block online access to explicit sexual material
- Amended to no longer include misdemeanor penalty, but allows for prosecution by the state and withholding of state funds to entities that do not comply
- Now excludes higher ed, but still includes public libraries, school libraries, and state agencies
- Would cost the state an estimated \$1,110,837 in the 2025-2027 biennium, then \$926,956 in the 2027-2029 biennium
- Hearing scheduled for 9 am on Tuesday, 3/18 in House Judiciary Committee
- NDU members, please submit testimony

Failed bills and resolutions

HB 1100 – School lunch debt forgiveness

- Would spend 2 million dollars to eliminate lunch debt
- Started in House Education, where it passed 14-0 and was referred to appropriations
- Appropriations voted 18-3 *do not pass*, saying things like "it's time for parents to step up" and "school lunches cost half as much as a happy meal"
- Failed 20-72-2

HB 1145 – Display ten commandments in schools and colleges

- Would require ten commandments in the cafeteria of all k12 schools and higher ed institutions
- Failed 38-53-3

HB 1179 – 24 days of paid time off for faculty on 12-month contracts

- Passed in the House 82-11
- SBHE opposes
- Was turned into a "shall consider" study
- Failed in the Senate 0-47

HB 1365 – Possession of firearms in public

- Failed 29-62-2
- All but two gun bills failed

HB 1457 – Expands exemptions for vaccine requirements

• Failed 46-40-7

HB 1475 – universal school meals bill

• Failed 39-54-0

HB 1553 – additional universal school meals bill

Failed 14-75-5

SB 2355 – Requires intelligent design to be taught "as a viable scientific theory for the creation of all life forms" in school science content standards

Failed 22-25

SB 2392 - Regulates prohibited discriminatory practices in higher ed, public schools, and state agencies

- Prohibits training and "submissions, statements, or documents" on what are considered "discriminatory practices"
- Some listed discriminatory practices include any concept that:
 - Asserts an individual, by virtue of the individual's personal identity characteristics, is inherently privileged, oppressed, racist, sexist, oppressive, or a victim, whether consciously or unconsciously.
 - Asserts an individual, by virtue of the individual's personal identity characteristics, bears
 responsibility for actions committed in the past by other individuals with the same
 personal identity characteristics.
 - Asserts that meritocracy is inherently racist or sexist.
 - Asserts that sociopolitical structures are inherently a series of power relationships and struggles among racial groups.
 - Promotes resentment between, or resentment of, individuals by virtue of their personal identity characteristics.

- Considers an individual's personal identity characteristics in determining receipt of state financial aid or other state financial assistance, including a scholarship award or tuition waiver.
- o Is referred to or named diversity, equity, and inclusion.
- Senator Wobbema did not realize a bill like this already passed in 2023 until President Armacost told him about it
- Wobbema recommended do not pass
- Failed 1-46 (Powers was the one yes vote)

HCR 3012 – to repeal section 10 of article X of the Constitution, which would eliminate the statewide property tax levy of one mill to support the UND Medical Center

• Failed 43-42-9 (needed 48 to pass)

SCR 4023 – to repeal section 10 of article X of the Constitution, which would eliminate the statewide property tax levy of one mill to support the UND Medical Center

• Failed 21-26-0 (needed 24 to pass)
