- e. Student #5 Requests to receive 3 credits for ENG 110, student took part in pilot study in semester 2006 with major of zoology. Student was told if he/she took ENGL 120 and received a grade of C she/he would receive credit for ENGL 110. Student changed majors to Horticulture in 2008. In recent graduation audit student has been told he/she needs credit for ENGL110 to graduate. Student has been told that because this is a different college it will not be honored. Student has petitioned College of AG and they have denied petition. Committee feels student has met GE requirements, does not want to penalize students for volunteering for pilot program and wants make this fair and reasonable for students. GE committee tables this motion and will discuss options from the Registrars Office for dealing with these situations in the next meeting.
- f. Student #6 Petitions committee to receive credit for ENGL 110 because student feels she/he have fulfilled the requirements for ENGL 110/ENGL 120 policy. Student came to NDSU in fall of 2006 and the policy requirement for ENGL 110/120 was that students would receive credit for ENGL 110 when they completed ENGL 120 with a grade of C or higher. Student also scored above 21 on ACT and could waive ENGL 110. Student took

- a. Student #1 requests accepting BIOL 220 (anatomy) from Mankato for Science and Technology category. This class is not Gen Ed course for Mankato and the content is not equivalent to NDSU's Gen Ed course. Recommendation from Subcommittee is to send back to student to further explain how course meets NDSU's Science and Technology criteria. Bob seconds subcommittee recommendation. Committee discusses, votes, and approves recommendation.
- b. Student #2 requests accepting LEAD 100 from Dickinson State College in the Social and Behavioral Sciences and Global Perspectives categories. Student petitioned for same course for Humanities and Fine Arts previously and was denied at the November 13 meeting. **Subcommittee recommends approving** for Social and Behavioral Sciences and Global Perspectives Categories. Linda seconds. Committee votes and approves recommendation.
- c. Student #3 requests waiving Global Perspectives based on transferred course work, fluency in multiple languages, and extensive international travel. The student's request for cultural diversity is already approved due to international student status. **No recommendation from subcommittee**. Bob makes motion to approve petition; Charles seconds; committee discusses, votes and approves.
- d. Student #4 requests waiving 1 credit in the Science and Technology category. Advisor supports request. Student has over 50 credits in 300-400 level engineering courses that exceed the general education Science and Technology requirements. Subcommittee recommends approving. Bob seconds and makes a motion that committee approve and set precedence for Registration and Records to have power to act on the committee's behalf and accept other petitions like this, and report back to committee. Committee discusses, votes and approves student's request to waive credit and also Bob's motion for precedence.

- e. Student petition #5 requests receiving credit for ENGL 110. Student participated in the First Year Composition pilot program in Fall 2006 and completed ENGL 120 with a B. Student transferred to a different college which did not participate in pilot program. That college insists that student needs to meet the college requirement of nine credits in written communication. Advisor supports request. **Subcommittee recommends denying petition.** Charles seconds. Committee discusses. Student will still need to complete upper division writing to meet college requirements for major. Committee votes 3 to deny petition and 5 to approve petition. Petition is approved for student to receive 3 credits for ENGL 110. Those in favor wanted the students in the pilot program to have the same benefit (credit for ENGL 110 if they passed ENGL 120 with a C or better) as subsequent students.
- f. Student petition #6 requests receiving credit for ENGL 110. Student completed ENGL 120 with a B in Fall 2006 although student was not enrolled in a college that participated in the First Year Composition pilot program. That college insists that student needs to meet the college requirement of nine credits in written communication. Advisor supports request. Subcommittee recommends approval, but student must complete 320 Upper division writing first. Charles seconds. Committee discusses, votes, and approves with one no vote.
- g. Student petition #7 requests substituting BIOL 150L: General Biology Lab as the corequisite lab for BIOL 111: Concepts of Biology. This petition was reviewed at the November 13 meeting and approved pending further information. Subcommittee recommends approval. Bob seconds. Committee votes and approves.
- 6. Science, Technology, and Wellness Subcommittee Report (Char, Bob, Tom)
 - a. HON 342: Colloquium in the Sciences Recommendation for approval (Science, Outcomes 1 and 6) as a new course. Committee votes to accept recommendation from subcommittee.

 - c. Social & Behavior Sciences, Quantitative Reasoning (Charles, Linda, Mary)
 - PSYCH 270-Abnormal Psychology, Category B with recommended outcomes 4 & 5. Subcommittee recommends 5 year renewal with no changes in outcome. Charles makes motion, Linda seconds. Committee votes to approve recommendation by subcommittee.

6. Report from Student Petitions Subcommittee: RaNelle, Virginia, Cory, Darshi

- a. Student petition #1 requests substituting a variety of science courses with a math component and a MATH 103 prerequisite for the Quantitative Reasoning requirement. These courses include CHEM 121, 121L, ECON 105, ECON 220, ANTH 350, GEO 300 and GEO 440. Recommendation from Subcommittee is to deny. Bob seconds. Committee discusses, votes, and approves recommendation to deny student petition because student provided no certification from Student Disability Services of claimed disability. Student should be urged to take advantage of campus tutoring services.
- Student #2 requests using BIOL 126L as co-requisite lab course with BIOL 126. BIOL 126L is currently being reviewed as a new course. Request moot because of recommended approval of BIOL 126L from Science and Technology subcommittee.
- c. Student #3 requests substituting NDSU CHEM 117L or 121L as co-req lab to the CHEM 106: Forensic Science course taken at St. Olaf. No course description provided. Majority of subcommittee recommends denying. Charles seconds. Committee discusses, votes to deny petition with 3 opposing. Suggest that if student can demonstrate that if there was a lab component in science classes taken at another college, to petition again.
- d. Student #4 requests the committee reexamine its decision to deny student's previous request (reviewed 10/23/09) to substitute credit from AP Physics exam for PHYS 120. Supporting letter from high school teacher notes course is now a dual credit course in

NDUS. Subcommittee recommends approving AP Physics Exam count as GE Science & Technology credits, but not substitute for PHYS 120. Tom seconds and Larry moves that committee approve and set a precedent for Registration and Records that a student AP Physics Exam to count as GE Science & Technology credit, and report back to committee. Committee discusses, votes, and accepts subcommittee recommendation and Larry's motion.

- e. Student petition #5 requests a waiver of both Cultural Diversity and Global Perspectives based on military service in Iraq. **Subcommittee recommends approving petition.**Catherine seconds. Committee discusses and approves petition because of the length of time in Iraq (8 months, similar to two semesters study overseas), nature of experience with other cultures, and strength of case student made.
- f. Student petition #6 requests a waiver of global perspectives due to placing into SPAN 201 and 202, and study abroad. **Subcommittee recommends approval,** Charles seconds. Committee discusses, votes, and approves subcommittee recommendation.
- 7. Request from liaisons in Registrar's Office interpreting policy #6 with respect to what constitutes an "advanced course with comparable content." According to RaNelle, they were disappointed to hear that BIOL 151/151L was being removed from Gen Ed but felt it could still count toward GE depending on how this policy is interpreted.
 - a. General Education Administration Policy Number 6 (page 24 of the Bulletin) states: "General education requirements can be met by successful completion of a course for which an approved course in the same department is a prerequisite or by successful completion of an advanced course in the same department with comparable course content." The first part of this policy was designed to take care of all those advanced courses in Math that many students take who already have a good math background. The second part of the policy was originally written to take care of the three levels of Physics courses (120: Fundamentals, 211; College; 251: University).
 - b. Question sent to Will Blier "Now that the department has withdrawn BIOL 151, the liaisons in the Registrar's Office are wondering if it fits under the second part of this policy. That is to say, does it have comparable course content (but at an advanced level) to one of the other GE courses--111, 124, or 150?" Email response from Will Blier, Biological Sciences: "No, neither BIOL 111, 124 nor 150 has comparable content to BIOL 151. The one that comes closest is BIOL 111, but its overlap with BIOL 151 is less that 50%."
 - c. Bob noted that the CCN standard for comparable courses is 70% common content.
 - d. Larry requests that committee members and liaisons in Registrar's Office review how many classes from their departments may be affected.

General Education Committee Meeting Minutes of the meeting of March 12, 2010

The meeting was called to order at 2:00 p.m. by Larry Peterson

General Education Committee Members present included: Robert Harrold, Catherine Haugen, Virginia Clark Johnson, Linda Langley, Cory Loveless, Charlene Myhre, Larry Peterson, Charles Stevens, Gary Totten, and Kristi Wold-McCormick.

Guests: Kevin Brooks, Andrew Mara, and Bruce Maylath.

Larry asked the members present to introduce themselves for the benefit of the guests and progressed to the discussion of Upper Division Writing. Kevin Brooks, Bruce Maylath, and Andrew Mara provided an update on the Upper Division Writing Courses and initiated discussion of potential levels of involvement of, and interaction with, the members of the General Education Committee. Kevin sought involvement of members of the General Education Committee in reviewing student portfolios and discussed the three hour involvement in portfolio review. He emphasized that it really helps the English Department understand the nature of the writing in other disciplines better when other faculty participate. Bob has done this previously. No one else volunteered at the meeting, but Committee members were interested and supportive of the portfolio reviews for both the First Year and the Upper Division Writing Courses.

Kevin also discussed the possibility of getting feedback about the Upper Division Writing (UDW) courses each semester from the General Education Committee. Committee members thought the writing concerns in their colleges were too diverse for any one member to represent adequately. A number of options were discussed including using the college list serves. Consideration of obtaining direct feedback from units providing students for individual UDW courses was encouraged as the General Education Committee would not represent an appropriate audience for comments about individual UDW courses.

The minutes of the meeting of February 12, 2010 were approved as distributed and Bob Harrold agreed to take notes in Sue Wolter's absence.

There were no student petitions to discuss and the report from the Humanities, Fine Arts, and Communication Subcommittee to recommend WGS 110: Introduction to Women's Studies (Categories A/D; Outcomes 3 & 6) and HIST 431: The North American Plains [Categories A/D; Outcomes 3 & 6 (Pending receipt of a revised syllabus)] was approved as distributed. There were no reports from the Science, Technology, and Wellness Subcommittee or from the Social and Behavioral Sciences Subcommittee.

Larry indicated that the procedure adopted by the General Education Committee of not accepting petitions to waive General Education requirements during a student's last semester, except in cases of extreme duress, had been presented at the meeting of the University Senate on March 8, 2010. A student representative expressed concern and it was explained that the action was a procedure rather than a policy. Members agreed that the essence of this new procedure was to be fair to all students by not taking the student's term of graduation into consideration when making a decision. Kristi volunteered to re-draft the statement to make that clear.

Discussion of information requested from the General Education Committee for inclusion into a matrix developed for the NDSU Diversity Plan emphasized that the matrix heading called for activities in 2005 – 2010 and had not been seen previously by the committee. The draft entries into the matrix were endorsed with the suggestion that Larry might rewrite selected sections. Kristi suggested that a cover memo might help describe the committee's position.

College Liaisons in Registration and Records had asked Kristi to seek clarification on courses taken by course challenge. These courses are graded on a Pass or Fail basis and the Liaisons sought clarification if this resulted in a conflict with General Education Policy #8 (for General Education courses) or if this was a unique instance of an exception for courses offered only on a Pass/Fail basis. The committee agreed that this represented a special exception to Policy #8 and did not represent a conflict.

Kristi requested the Committee's permission for her office to grant waivers to a cluster of students in Architecture and Landscape Architecture who are being disadvantaged by the withdrawal of BIOL 150, 150L, 151, and 151L from the list of approved General Education courses. The Committee agreed.

There was a short discussion of Mid-term grading.

No additional business was presented and the meeting was adjourned at approximately 3:05 p.m.

- 1. Meeting called to order 2:00 pm. Gary Totten volunteered to serve as recorder.
- 2. Larry suggested a change to the minutes. The action for student #6 (HD) should read, "The recommendation from the subcommittee is to return the petition to the student to resubmit with a syllabus for the course and to explain how it meets the Science category." No other changes suggested by committee. Minutes approved.
- 3. Departing members (Langston Johnson, Cory Loveless, Charles Stevens) were recognized for their work on the committee.
- 4. Student Petitions. Larry asked for a motion to make them a consent agenda; Cory and Bob so moved; Linda seconded; and the Committee approved.
 - a. Student petition #1 (SE) requests substituting transfer course in Computer Science into Quantitative Reasoning. Student provided syllabus and rationale. Subcommittee recommends approval of petition.
 - b. Student petition #2 (FN) requests substituting transfer course ASIA 253: Japanese Culture into Humanities and Fine Arts. Student provided syllabus and rationale. Subcommittee recommends approval of petition.
 - c. Student petition #3 (JB) requests waiving one credit of Quantitative Reasoning because student took CSI 159: Computer Science Problem Solving for two credits. (Now it is only offered for three credits.) Subcommittee recommends approval of petition.
 - d. Student petition #4 (BM) requests waiving Cultural Diversity requirement based on National Guard experience, primarily in basic training and deployment in various parts of North Dakota. Subcommittee recommends denial of petition.
 - e. Student petition #5 (MK) submitted five requests based on study abroad in Korea. Subcommittee appreciates student's pro-active approach, but the study abroad registration process has not been allowed to work through the appropriate channels with respect to the NDSU depts. reviewing and determining potential course equivalents. The two requests (#s 3 & 4), however, that could be considered at this time are the requests for the Korean language courses (I & II) since NDSU does not teach Korean. Similar to the Arabic requests, the recommendation is to approve HUM/FA and global perspectives for these two requests.

Larry asked if there were any questions about the petitions from the committee.

Charles asked about petition #5 (MK). RaNelle recommended that the appropriate departments be allowed to complete the process of reviewing the student's petition. The student is being proactive, but hasn't allowed the process itself to work. The Summer 2010 Korean courses she is planning to take would approved for HUM/FA and global perspectives "pending" her completion of the courses

One more student petition posted just before the meeting: BN is requesting waiver of ENGL 120. Student transferred a technical writing course from a law enforcement degree at a community college, which did not transfer as equivalent to either ENGL 110 or ENGL 120. Student got credit for ENGL 110 because due to earning a "B" in ENGL 320 at NDSU. After discussion about the overlap between ENGL 120 and the transfer course, Linda moved; Mary seconded, and the Committee approved the student's request to waive English 120.

5. Subcommittee Reports:

Social and Behavioral Sciences and Quantitative Reasoning. Moved, seconded, and approved to approve new Gen Ed course (HNES 355) and continued approval (5-year) for CDFS 475.

Three courses sent back for revision (CDFS 230, CSCI 122, EMGT 101).

- 6. Larry reported on ND Gen Ed Summit. Chancellor is pursuing North Dakota's participation as a LEAP state. The summit adopted a working constitution for a ND Interim General Education Council. The summit agreed that all the AACU's learning outcomes were important, but attendees were not sure how to assess some of them. The latter two matters should be completed at the September summit in Bismarck.
- 7. Action item: what to do about course reviews not completed by 4/30/10? The recommendation is to send letters to departments who have not yet submitted reviews or revisions. These letters should be more strongly worded if a course has been several years past the due date; for example, courses like CHEM 121 and CSCI 159.
- 8. Charles noted that online courses create difficulties in assessing GE outcomes (e.g. if an outcome is based on class discussion, the face-to-face class would

- meet this outcome while the online version of the same course would not). This will need to be a matter of discussion in future reviews.
- 9. The people who attended the AACU General Education Institute in May 2009 (Bob, Larry, Char, Kevin McCaul) will meet with the Provost on May 11 to review the nominations for members of the Ad Hoc Undergrad Curriculum Review Committee.
- 10. Possibility of a summer meeting if appeals warrant it.
- 11. Meeting adjourned 2:40 pm
