## **NEW BUSINESS**

The committee discussed district roles and responsibilities. There are several counties who are missing Oaths of Office forms, Reorganization forms and Supervisor Training forms. Sandy stated that these requests are emailed to all scds in December of the current year and they have until March of following year to submit the requests. Also, many scds are late in supplying a copy of their board meeting minutes. Several email requests go unanswered.

As it stands today, Mouse River SCD is non-compliant with ND Century Code 4.1-20-18. It was decided to form a committee (Wes Frederick, David Hill, Sandy Schwede, Lindsay Maddock, Jodi Delozier & Andrea Bowman) to formulate a plan to assist Mouse River SCD to get back on track.

Wes read the letter (attached) that Aaron Field, NDSU Extension State Soil Program Leader and David Hill, Area III Supervisor had compiled and mailed to the Bottineau County – Mouse River SCD board members and scd office on May 18, 2022. Amanda Cartwright responded to the letter via email on June 14, 2022.

The committee discussed withholding DART Quarter 2 payment for which reporting is due July 15, 2022. Release of payment is contingent upon Mouse River SCD meeting the requirements as put forth in the letter from Aaron. IT WAS MOVED BY COMMITTEE MEMBER GRANN, SECONDED BY COMMITTEE MEMBER HILL TO WITHHOLD 2<sup>ND</sup> QUARTER DART PAYMENT FOR BOTTINEAU COUNTY – MOUSE RIVER SCD UNTIL REQUIREMENTS ARE MET.
