\*Refund Policy-Refund rates for individual class drops and term withdrawals are in accordance to North Dakota University System policies and procedures. Calculations are based on each class' start and end dates (not always the same as above session dates), and includes all calendar days, not just class days. Withdrawal to Zero Credits: Refunds are prorated based on actual class start/end dates. Students will forfeit any grades earned if a term withdrawal is processed after the conclusion of a course(s). Individual course drops are subject to 'Course Drop' deadlines/refund policies. Term withdrawals are refunded as follows:

## 100% refund - on classes withdrawn during 0% through 8.99% of class length

75% refund - on classes withdrawn during 9% through 34.99% of class length 50% refund - on classes withdrawn during 35% through 59.99% of class length

0% refund - on classes withdrawn on or after 60% of class length

## Course Drops:

Individual course drops are refunded at 100% through 8.99% of the class length. No refunds are issued after this point for course drops.
