1. CALL TO ORDER

President Nancy Olson called the meeting to order.

2. ANNOUNCEMENTS

Yes, that is exactly right.

3.2 Modem Pool

Val Tareski (Computer, Planning & Goals Committee) and Bonnie Neas (Director, ITS)

3.2.1 Val Tareski – "What is the campus obligation in providing access to campus computer services"?

There are 149 modem lines available for students, staff and faculty to use. If you look at the modem usage (this can be found at

http://www.ndsu.nodak.edu/ndsu/hoag/ts/tsweb.html), from about 6 pm until 1 am, all modems are being used. There is no question that there is a demand for the use. The 149 modems appear to be inadequate for the demand that is presently being put on it.

CPG is conducting a survey of the faculty, students, and staff. As of today, the results of the survey have not been collated. We hope to have this done in the next couple of weeks. Indications are that there is a significant part of our population (students, staff and faculty) that would be inconvenienced or would find it a major problem to get access to computer resources on campus, either by only coming to campus or having to purchase access from home.

CPG is trying to address the questions "What exactly is the University's responsibilities in providing such services?" and "How does this compare to providing Library services?" Both are information services. As more students are required in their course work to have access to information by way of web access. If the off-campus students only means of having access to this information is by coming on campus or is it unreasonable to provide reasonable means for these student to have access, via the modem pool.

3.2.2 Bonnie Neas – What is driving this, is that the ITS budget is having more and more demand being placed on it. It got real serious, when the institution was asked to provide a 95% budget. The modem pool was the only service in ITS that met the 95% Budget criteria.

ITS feels that access is not the issue, there are alternatives to access. ITS feels that the issue is how does the University provide for this important service and who pays. The modem pool services started a number of years ago, because there were not local Internet Services Providers (ISP) in this area. At the time NDSU felt is was important to provide this service. Today there are many ISPs in the area, so the modem pool service does have alternatives.

A hand out was provided showing what is the current cost of maintaining the modem pool service (\$147,432/year). Most of the current equipment is getting old and needs to be updated, even if we stay at the current speeds of 28.8Kbps, expected cost of upgrading the equipment is about \$219,528/year. If we were to upgrade the equipment to faster modems (56K), this cost is estimated to be about \$278,304/year. This does not include adding any additional lines.

The handout also shows some of the other services that are needed on campus. These include: web development and support team; classroom media services; desktop research technical support specialist; building network upgrades for about 26 buildings; classroom technology; Y2K desktop remedial software; and a new 30 machine student cluster. Not on this handout, ITS upgraded our Internet capacity by about 75%, while the cost increase only by 35%. Even with this increase, our Internet traffic is still maxed out.

What does this University want? ITS is looking for input from the campus to help us make the decision to provide better services.

Please make recommendations to ITS and CPG by May 1.

3.2.3 Questions:

"One of the issues on access, when you use your own ISP, you can not send mail out through your NDSU e-mail account, you have to use your ISP's e-mail"

This is an issue that is going on at universities all over the country, including UND and Minot State. The issue here is authentication, how do we authenticate who is a NDSU users and who is not. We are working on this. This is used for many of the information services provided on campus. As an example, the library provides many services that are available only to NDSU students, staff and faculty. How do we leave things open enough so that students, staff and faculty can get access from anywhere, but still guarantee that only NDSU students, staff and faculty have access. Security is a big issue.

"In order to expand services with additional funds, what are some of the sources for these funds?"

- The state
- Grants, this years ITS has almost \$1 million in grants
- User fees, this is the last option

"What are the grant sources?"

Primarily from Federal agencies, like the National Science Foundation (NSF). ITS has not had a lot of luck with private agencies, primarily because of finding matching funds.

"Over time, do you believe that funding sources for grants will be more difficult to get?"

Currently, at the Federal level, the Clinton Administration has asked for a big increase in the Information Technology area for grants.

"Has the idea of building a relationship with local ISP been looked into?"

About a year ago, ITS did have several conversations with USWest, and it is still a high cost service. ITS is talking with other ISPs to see what they can offer. A lot of cities and universities are having success with cable modems. USWest does offer ADSL, but there are a lot of problems with this.
