## 3. PROGRAM

United Blood Services; Pat Cossette, Community Relations Rep and JB Gaskens, Executive Director

This area is one of the greatest donating communities in the nation percentage-wise with the highest per capita than any other blood center in the United States.

The Fargo UBS services parts of SD, ND to Jamestown, Northern and Western parts of MN as far as 300 miles away, providing blood to 43 medical facilities.

NDSU blood drive numbers were down this year, JB asked, "W hat can we do to help you the faculty, reach the people that we need to reach to get the blood donors we need?"

- **Q** Other clubs held a blood drive the day before the Staff Senates did this affect our numbers?
- A Pat No, they pull in donors from their student numbers, not staff.

  JB the plasma center could be one reason our numbers are down

- Can you draw blood at the new student health center so someone could plan on donating there every 8 weeks?
- A/Q The blood mobile can be claustrophobic.
- Pat going to look into that. Also, UBS has a new blood mobile, much roomier.
- Q Some times certain places won't take A-B blood, where would be the best place someone could go to donate A-B?
- JB they could specifically donate platelets or plasma at UBS. Α
- Q Provide more outreach education for people who haven't donated before.
- Α JB - is there an avenue through this group to get the information out?
- Word of mouth, we need to talk to our friends, tell them how important this is. Α
- Sharing personal experiences may be more affective than statistics. Α
- Α JB - changes have been made that we need to let people know. The upper age limit has changed, if someone hasn't had a flare up of malaria in the last three years they can donate, if they had hepatis before age 11 they can donate.

Thorsen voted against the proposal because she didn't feel it was appropriate for this budget-affecting action to come out of the HRC without a fiscal analysis and discussion by the University System Continuing Education group. The proposal will proceed to the University System Administrative Affairs group (Business Vice Presidents).

# 9. POLICY COORDINATION COMMITTEE - PCC (Allyn Kostecki)

Met on October 15<sup>th</sup>. There were several policy changes:

Section 169 - Employee Misuse of Public Property, reflects the state law and clearly outlines the supervisor's role.

Section 304 - Academic Staff and Administrative Positions, reflects changes in the broadbanding system.

Section 406 - Surplus Property, addresses the confusion with the rules of handling property. States that property that is to be scraped or discarded must be handled through surplus property rules.

Section 514 -Personal Use of State Property, brings in restrictions for private use of public property.

Section 719 - Internal Auditor, establishes NDSU policy on the designated position of Internal Auditor, their rights and responsibilities and the access they have to our departments.

Teri T. added that the even though the Physical plant has been discussed, the confusion mentioned regarding property use has been campus-wide.
