Minutes from the May 9, 2001 Staff Senate Meeting Reviewed by the Executive Committee on May 23, 2001

1. **Meeting called to order:** Allyn Kostecki called the meeting to order and introduced himself to the new senators. He welcomed all in attendance and offered a special thank you to all retiring senators for their hard work and dedication.

Substitutions: Sandy Scott substituted for Dawn Holm and Carolyn Flink represented Darlene Jenson.

- 2. Review and approval of the Staff Senate Minutes from April 11, 2001: No additions or corrections were noted. Susan Bornsen moved that the minutes be approved as written. Dan Chihos seconded the motion. Motion carried by unanimous vote.

4. Program: Election of Officers and Representatives

Certification of new senators: Note in the records that Paul Johnson needs to be added to the list for the 7000 band. Char Kuss moved to ratify the election. Janine Trowbridge seconded the motion. The motion passed by unanimous vote.

Char Kuss moved to destroy the ballots. Linette Knoll seconded the motion. No further discussion ensued and the motion passed by unanimous vote.

Computer Planning and Goals (1 representative and 1 alternate):

Dan Chihos noted that Steve Kapaun served as the representative last year and that he was the alternate. He supported that the same positions carry forward into the coming year. Paul Johnson moved that a unanimous ballot be cast for Steve Kapaun and Dan Chihos and that the position of representative and alternate continue in the same manner as last year. The motion passed by unanimous vote. No ballots were required. Steve Kapaun will serve as the representative for CPG and Dan Chihos will serve as the alternate for 2001-2002.

5.3 University Senate

Library (Candy Skauge for Kathy Enger): Last week the area contractors and architect did a walk through in the basement. The bids are supposed to be in by the end of this week. Hopefully the work on the basement will be started by the end of May.

5.4 Other:

Council of State Employees – COSE (Valerie Larson): They met in Grafton on April 19, 2001, and received a great tour of the Development Center. The COSE newsletter is out. If you know of anyone who didn't receive one, please notify Valerie Larson to add the name(s) to the list. Valerie Larson is scheduled to serve on COSE until December 2003 and Sharon Morgan until December 2002.

6. Advisor Comments (Teri Thorsen): Teri noted that salary guidelines have been sent out to all department heads. The \$35 across-the-board raise was approved with additional 2% and 3% pools also approved. They have asked for the authority to put salary information and guidelines on the web page so that individuals may have access to the information. No permission has been granted yet. Due to the legislature running so late, salary/employment letters may not be available as of July 1.

7. Other Old Business:

Tuition waiver: Allyn Kostecki noted that the tuition waiver for staff and faculty that was not passed by legislation was not the one that the Staff Senate had proposed. Our proposal is at the State Board of Higher Education for review. The Chancellor's Office asked that it not be legislative business. The tuition waiver proposal sent forward by the Staff Senate asks that we take our current tuition waiver (each employee may have tuition waived for up to 3 classes per year) and extends that benefit to the employee's spouse and/or dependent children. The President is supportive of the proposal. If approved, the proposal will transfer to all participants within the NDUS system. Currently, self-supporting classes are not covered under that plan.

8. Other New Business and announcements:

Allyn provided a view of the committees for Staff Senate on the overhead projector. Each senator serves on a committee. Returning senators may continue on the same committees as last year. New senators may review the committees and choose which one they wish to serve on. Allyn will be sending an email that will address the process of committee selection. New senators are asked to provide a first, second, and third choice in the email response.

STAFF SENATE – LEGISLATIVE COMMITTEE YEAR-END REPORT MAY 9, 2001 SUBMITTED BY: JANINE TROWBRIDGE

It has been a very productive year for NDSU during this years' legislative session. NDSU was fortunate to receive appropriated funds and has been granted permission to raise additional funding for necessary renovation projects on campus. You will see work at Minard Hall, Robinson Hall, F Court and Sudro Hall. \$7.6M has been appropriated for a new state-wide computer system.

For state employees the 3%/2% increase is in place for the next biennium. Excess funds from the Life Insurance fund will be distributed to pay down the cost of state employee health insurance and the Benefit Multiplier increased from 1.89% to 2%.

As first time committee members, we found this to be an exciting and educating experience. It was especially rewarding to have had the opportunity to work with Keith Bjerke. Our weekly meetings with Keith kept our senate informed of the latest events in Bismarck and provided Keith an opportunity to receive feedback and reactions from staff on legislative issues. We certainly hope that this relationship with the President's office will continue in the future.

HB 1099 Reallocation of Excess Funds From Life Insurance

Relating to state retirement board authority over excess uniform group insurance program funds; relating to the definition of eligible employee, retiree eligibility for the group health insurance program and retiree health benefits, and excess funds and confidentiality of records under the uniform group insurance program; and to provide a transfer. Signed by Governor, filed with Secretary of State.

HB 1015 Employee Compensation Adjustments

Relating to state employee compensation adjustments. Signed by Governor, filed with Secretary of State.

HB 1216 Wald Grande

Relating to participation in the defined contribution retirement plan. **Signed by the Governor**.

HB 1217 Wald Grande

Relating to eligibility to participate in the defined contribution retirement plan. **Failed to pass the Senate.**

HB 1435 Anti-Affirmative Action

A BILL for an Act to provide for a prohibition on discrimination and preferential treatment by the state. **Conference committee dissolved, no further action.**

SB 2003 NDUS Appropriations/Salary Bill

(At the request of the Governor) A BILL for an Act to provide an appropriation for defraying the expenses of the North Dakota university system; and to declare an emergency. This bill was amended to include provisions from SB2037 (tuition income) and 2038(block grants). **Sent to Governor**.

SB 2023 Appropriation for Capital Projects



STAFF SENATE - LEGISLATIVE COMMITTEE YEAR-END REPORT CONTINUED:

(At the request of the Governor) A BILL for an Act to provide an appropriation for capital projects of various state departments and institutions; to provide an appropriation for state facility energy improvement capital projects of various state departments and institutions; to authorize the industrial commission to issue and sell bonds for capital projects; to provide an appropriation; and to declare an emergency. **Signed by Governor, filed with Secretary of State**.

SB 2039 SBHE to Approve Construction

Relating to legislative approval of capital improvement projects financed by donations, gifts, grants, and bequests. Signed by Governor, filed with Secretary of State.

SB 2040 Removes NDUS from reports by OMB on Bonuses

Relating to reports to the budget section of the legislative council of irregularities noted in fiscal practices of state agencies and institutions. **Failed to pass the House**.

SB 2041 Higher Ed Roundtable Strategic Planning

Relating to the North Dakota university system; relating to the higher education system strategic plan. **Signed by Governor, filed with Secretary of State.**

SB 2042 Relating to the powers and duties of the state board of higher education and several other state agencies. **Signed by Governor**, **filed with Secretary of State**.

SB 2082 Increases Benefit Multiplier From 1.89 to 2.00 %

Relating to purchase of service credit under the public employees retirement system; relating to funding of administrative expenses of the deferred compensation plan, computation of benefits, determination of normal retirement date, beneficiary designations, cost of credit purchases, postretirement adjustments, prior service retiree adjustments, confidentiality of records, and deferred compensation under the public employees retirement system; relating to prior service retiree adjustments under the public employees retirement system; and to provide an effective date. **Amended bill signed by the President of the Senate**.



STAFF SENATE – UNIVERSITY ATHLETICS MAY 9, 2001 SUBMITTED BY: TAMMIE REGER

The University Athletics Committee met on April 23, 2001. Welcomed guest, Mr. Troy Goergen, Assistant Athletic Director for Marketing, Promotions and Licensing.

Constitution & Bylaw Revision

The changes previously distributed were reviewed. An additional change to Bylaw V, Section 2 was discussed. All revisions were approved.

Athletic Director Search

Two candidates, Joel Erdmann and Gene Taylor, have already interviewed. Al Molde will interview this week. Strengths and weaknesses of each candidate will be presented to President Chapman on April 30. All candidates were impressed with the NDSU's search process.

Men's Basketball Staff Changes

Tim Miles accepted head coach position. Todd Koering and Craig Smith accepted assistant coach positions.

Student-Athlete Council Action

Student-athletes helped with flood and other community projects. A Sports Commission is being formed to interface with Student Government in fostering school spirit. A representative for the UAC will be elected in the fall.

Schedules for 2001-02

Al Fischer & Tim Riley will prepare report of classes missed, by sport, due to travel and competition and a report will be presented to UAC.

Marketing Plan for Athletics

Troy Goergen reviewed the purpose and strategic analysis of the athletic marketing and promotions department. Discussed the need to increase exposure of national championships and honors. (e.g. Wrestling National Champs visit White House). The new athletic director's focus will include customer feedback and surveys.

Student Finance Commission

Additional funding was awarded to athletics for 2001-02.

Student Seating

Student Government requested Section 17 at the Fargo Dome for student seating for football. Section 17 is comprised of Team Maker and season ticket holder seating and the financial impact of moving these groups would not have been off-set by the increase in funding from the Finance Commission. Currently students have all of sections 13-16; will add bottom half of sections 10, 11 and 12 amounting to an additional 1200 seats. In sell-out situations, students will receive all of sections 10 and 11. Thunder Alley is proposed for student section to promote school spirit.
