Carter encouraged senators to participate in a similar campus-wide exercise for MLK Day as well. President Barb Geeslin thanked Carter for coming and engaging Staff Senate in this activity.

- I. Meeting was called to order by President Barb Geeslin at 9:30 am.

III. Approval of Agenda.

MOTION (Dallmann/Boschee): to approve the agenda. MOTION PASSED WITH UNANIMOUS CONSENT.

IV. Program.

Guest Speaker – Jane Vangsness, Alcohol & Other Drug Prevention Coordinator. Vance Olson introduced Jane Vangsness, NDSU Alcohol and Other Drug Prevention Coordinator. High-risk drinking has been identified as the most serious public health problem facing U.S. colleges and their students. NDSU strives to educate individuals about the dangers of alcohol and drinking since it affects student success, student retention, and other factors. Vangsness acknowledged that many staff members are involved in this prevention program on campus. She engaged senators in a written exercise about drinking and encouraged them to browse the website (http://www.ndsu.nodak.edu/ndsu/alcoholinfo/) and to watch the video (under the Families link) about alcohol use.

III. Approval of the December 12, 2007, meeting minutes.

MOTION (Bromley/ Christianson): to approve the minutes. MOTION PASSED WITH UNANIMOUS CONSENT. Staff Senate minutes are available at http://www.ndsu.nodak.edu/staff_senate/meetings.shtml.

VI. Treasurer's Report.

President Barb Geeslin presented the Treasurer's Report. There are fund balances of \$465.53 in appropriated funds and \$10,688.29 in local funds.

VII. Committee Reports.

A. Election – Steve Bergeson.

Bergeson reported that Theresa McMullen has resigned her senator position in the 4000 band, so a senator seat is now open. Senators were encouraged to talk to colleagues who may be interested in a nomination for this seat. He reminded senators that it is not too early to think about the May election and, again, to talk to fellow staff members about serving as a staff senator. There are still several openings in the 6000-7000 band. Barb Geeslin continued by encouraging senators to consider running for an office as well, as it is very rewarding.

B. Policy Coordination Committee – Gretchen Bromley.

Bromley presented one policy from the Policy Coordination Committee. **For Input:** Policy 153 – Smoke-Free Facilities See <u>Attachment 1</u>

MOTION (Dallmann/Prunty): to support the policy as proposed. President Barb Geeslin clarified that discussion would be limited to the proposed policy only, not to discussion of the health issues nor implementation, and each person would be allowed one and a half minutes to speak. She mentioned various resources available for those wanting education on the effects of tobacco or smoking. Discussion ensued regarding the following points:

- Concerns were raised about the health risks of smoking.
- There was clarification of the current policy as compared to the proposed policy.
- The proposed 50-foot rule was questioned.
- Concerns were expressed about how the 50-foot rule could be implemented while others voiced support of the 50-foot rule.
- A question was raised about where ashtrays would be located.
- A question was raised about what next steps would be.

Steve Bergeson, senator who served on the committee that drafted the proposed policy, clarified that the 50-foot rule means away from buildings, not just entrances. MOTION CARRIED.

C. Program Committee - Vance Olson.

Olson announced that guest speaker at the February meeting would be Vice President Prakash Mathew. Sheree Kornkven, Student Technology Services Coordinator, has also been asked to speak.

D. Public Relations Committee - Gretchen Bromley.

Bromley reported on the Holiday Blood Drive. It was an exceptional drive with many walk-ins. Blood Services indicated that these donations could save up to 162 lives.

E. Scholarship - David Slyter.

Slyter indicated that Staff Senate Scholarships are now being announced across campus with an application deadline of April 4, 2008.

F. Staff Development - Vicki Miller.

The all-day DISCOVER U staff development workshop is ready to be held on February 6 in the Memorial Union. Eighteen door prizes have been secured. Advertising is just beginning. Miller is collecting registrations; the cost is \$20.

VIII. Old Business.

Valentine's Ball - Vance Olson.

Olson announced that the Valentine's Ball is one month from today - Saturday, February 9. President Chapman has donated \$1,500, and this was matched by Staff Senate with another \$1,500. The committee is seeking door prizes to give to each person who attends the ball. Faculty members are still sought to assist in the planning process.

IX. New Business.

A. Parking - Ron Haugen.

Ron Haugen, substituting for Jeanne Flood, reported to Staff Senate that, as a six-month employee, he is now required to pay for a full year of parking instead of a half year as in the past. He inquired about whether this could be investigated further.

B. Non-Discrimination Policy.

The Non-Discrimination Policy statement will be added to the minutes and the agenda from now on. Policy 100 contains the exact wording.

X. Advisor Comments – Broc Lietz. None.

XI. Announcements.

Upcoming Elections - Barb Geeslin.

President Geeslin once again encouraged nominations for senate seats and asked senators to consider running for offices.

XII. Adjournment.

MOTION (Mickelson/Adams): to adjourn the meeting. MOTION PASSED WITH UNANIMOUS CONSENT. The meeting was adjourned at 10:30 am.

SECTION 153: SMOKE-FREE FACILITIES

SOURCE: SBHE Policy Manual, Section 917

North Dakota Century Code 50-11.1-02.2 NDSU President Definitions:

For the purpose of this policy, "smoking" is defined as having in one's possession a lighted tobacco product such as a cigarette, cigar or pipe.

Policy:

- 1. <u>Smoking is prohibited in North Dakota State University buildings, residence halls and enclosed structures</u>.
- 2. <u>Smoking is not permitted in a child care facility or near children enrolled in the facility.</u>
 (ND Century Code 50-11.1-02.2)
- 3. Outdoor smoking is permitted only in those outdoor areas at least 50 feet from buildings.
 - Entities exempted from Policy 153, Section 3 include private companies in the NDSU Research and Technology Park, leased properties, Northern Crops Institute, and Newman Outdoor Field.
- 4. Smoking is prohibited in state-owned or leased vehicles and motorized equipment.
- 5. The smoking prohibition does not apply to specific activities used in connection with the practice of traditional spiritual or cultural ceremonies. Ceremonial use exceptions must be approved in advance by the Vice President for Student Affairs.
- 6. Faculty, staff, students and visitors to NDSU are covered by this policy.

Institutions may permit smoking areas in outdoor arenas, provided that smoking is prohibited in all restrooms and other enclosed areas.
