The meeting was called to order by President Vance Olson at 9:35 a.m.

IV. Student Government Report.

Joe Heilman, Student Government President, presented the Student Government Report, a new item on the monthly Staff Senate agenda. He reported that students donated \$6,000 toward holiday decorations for around campus, and have donated \$28,000 toward special project requests on campus. They have started a new radio show on the NDSU station at 96.3. Students are active on the Sustainability Task Force, and the Legislative Task Force is also in place and ready. They have begun the Collegiate Readership Program as a pilot program. The "Fill the Dome" food donation project has been a big success.

V. Program:

Ray Boyer, Director of University Policy and Safety Office, was introduced by Kris Mickelson. Boyer spoke of the new Campus Emergency Notification System (CENS) being tested to meet federal compliance requirements. NOTIFIND is the product selected by the state; and it includes email notification, home phone calls, and text messaging to cell phones in campus emergency situations. The November 3 "real" downtown incident was a test case, and there were lots of issues that surfaced with it. They are working through these issues and are trying to meet program safety objectives with the least inconvenience to all.

Jonathan Foss was introduced by Kris Mickelson to talk about the 2008 Dance Marathon. The Dance Marathon is a fund raiser for Children's Miracle Network. This is the second year of the 12-hour dance event to be held on December 5, 2008 at 7pm at the Bentson Bunker Fieldhouse. People can donate online and can sponsor a dancer at an hourly rate.
