### Scholarship Fundraising Ad Hoc Committee December 15, 2011

The Scholarship Fundraising Committee met on December 15, 2011 to discuss a Homecoming tailgating event and a raffle as potential scholarship fundraising activities. The committee has two recommendations for Staff Senate:

- 1) In considering the homecoming tailgating event, the committee determined that that the financial resources needed to successfully make a notable presence in the tailgating area, including costs for food and reserving a space within the area have the potential to be significantly higher than the scholarship revenue generated. The committee felt that having to invest a significant amount of money in an event where external factors such as weather, attendance, and other "competing" fundraising activities have a significant potential for making the event a net loss to the Staff Senate is not an effective use of resources. The committee therefore recommends that Staff Senate discontinue efforts toward coordinating a tailgating event at this time.
- 2) In considering a raffle for scholarship fundraising, the committee determined that the relatively low cost for acquiring donated prizes, obtaining a permit and printing tickets was an effective way to raise scholarship funds with little to no risk of adversely affecting Staff Senate's budget. The committee has been in contact with the city Auditor's Office and the NDSU Development Foundation and is discussing the foundation's ability to assist with the procurement of the appropriate permit and handling of funds from the raffle should Staff Senate decide to go that route. Additionally, the committee has compiled a list of local and regional businesses from which raffle prizes can be solicited. It is the recommendation of the committee that Staff Senate pursue a raffle as an event to raise additional funds for the general student scholarship.
