ATTACHMENT I

PRESIDENT'S CABINET from Elizabeth Worth

- NDSU/UND Research Initiative
 - Continues to gain momentum... surprisingly has still not met resistance
 - o If research funding were granted, the desired result would be people and program growth
 - Valley Prosperity Group is the force behind this initiative... some have mentioned that PP may have a slight negative connotation west of Cass County (b/c of the reference to "Valley") and suggested rethinking a broader name
- Governance of Higher Ed
 - As of the last SS meeting, three models remained in contention for the task force to recommend
 - Full-tiered model: NDSU/UND board, 4-year board, 2-year board (seemed to be the least popular)
 - 3-board model: NDSU board, UND board, board for remaining 9 institutions
 - 4-board model: NDSU board, UND board, 4-year board, 2-year board (overarching these four boards would be a coordinating committee that would take care of administrative kinds of things (TIAA CREF, articulation stuff), but would not have "control" over the boards... all actual decision-making would occur at the board level
 - Next steps would be to get into the details of these options (or of the one they ultimately recommend) in terms of how many board members there would be, how they're nominated/chosen, how long the terms are, etc.
- VPRCA
 - Unicarta is a tech company doing mostly electronic manufacturing packaging using clean rooms, etc., as a tenant in the research park. There are two more (tentatively) in the wings to rent space... and a committee is being formed to look at utilization for the rest of their space
 - A year or so ago, they went through a process of redoing the bonds in order to reduce limitations for bringing in private sector partners, so the space can go from being an expense to us to being a source of revenue and a catalyst for private/public partnership in research
- Provost Grafton
 - Still visiting with departments across campus (dept chairs, deans, other units)
 - Trying to address the budget shortfall of approx.. \$6 million
 - As part of the shortfall is due to a drop in enrollment, they are looking at ways to enhance enrollment growth as part of an overall budget reduction plan
- Student Affairs/Enrollment Management
 - Casey Peterson led a design thinking exercise with about 50-60 faculty and staff members as part of collaboration efforts across various learning services on campus
 - Many no-cost ideas were generated to help share work across already-existing services
 - Results should be out soon

- Discover NDSU visitors were up this fall
- National College Fair was held in Mpls recently (it's the biggest in the country).. they didn't have final numbers but said the event was very engaging
- Counseling Center is overflowing with students, even though enrollment is down... they are managing, but visits are very high and just goes to show the student need right now
- Athletics
 - Our APR (academic progress rate), which tracks retention and eligibility for student athletes, is above the guidelines across the board... this means our Athletic programs may qualify for additional funding
