 - B. Birgit Pruess She is on SBHE so knows slightly about task force. SBHE is trying to update the task force members on how it all works. A staff member from Bismarck is on the task force who can be our contact if we want to bring something up or find out what is going on.
 - C. Chris Wilson He talked about the organizational structure of the State Board of Higher Education (SBHE). The SBHE was created to keep political autonomy (the board would act as a buffer) and has largely worked. We cannot have political officials telling our faculty/researchers how to teach a class or what to put in their research to maintain political autonomy. Governor Burgum has the task force to decide if SBHE is the best structure for ND (looking at what other states are doing). Right now, SBHE has 8 voting members which includes one student (article 8). This article also creates commissioner of Higher Ed which was replaced with the Chancellor in the 1990's (name change only really) and this created the system office for budget regulation essentially. SBHE/NDUS/then the Universities-President's report to the Chancellor but only SBHE can fire the president as the Chancellor doesn't have the ability. Andy Wakeford is the staff representative on the SBHE for us. If it's an internal issue, voice your concerns, sometimes just by calling them up (call Chris). If needed, formally we can bring up matters through our staff senate. If it's not an internal issue because some things NDSU can't control, then go through Andy. Chris wants to remind us that the SBHE meetings are open.
