NDSU alumnus Harry D. McGovern, BS '66, civil engineering has presented a \$1 million gift to the NDSU Alumni Center. In recognition of the donation, the building will bear his name.

A special dedication and open house are scheduled for Saturday, Oct. 6, at 8:30 a.m. at the Alumni Center, located at 1241 N. University Drive. Alumni and friends are welcome to attend

"On behalf of 75,000 alumni around the world, we are grateful for Mr. McGovern's very generous gift for the NDSU Alumni Center," said Wayne W. Schluchter, Alumni Association president. "When alumni step forward and place their name on an NDSU facility, it demonstrates respect, pride and loyalty toward the university. Mr. McGovern's gift symbolizes great generosity which enhances awareness about philanthropy as it will be seen by alumni, the community and current students each time they enter or pass the Harry D. McGovern Alumni Center."

McGovern, who graduated from Erie, N.D., High School in 1962, is co-owner of MCM Construction Inc., a major bridge and highway contractor with offices in Sacramento and Los Angeles, Calif.

"Even though I have been away from North Dakota for nearly 50 years, I have always taken great pride in the NDSU sporting achievements and the fact that I graduated from this great university," McGovern said. "I consider this gift an investment in North Dakota and North Dakota State University."

Jonal Uglem, president of the NDSU Development Foundation board, said, "The building of the Alumni Center was the realization of the dreams of many dedicated NDSU alumni and foundation trustees. It is the welcome center, a gathering place for alumni and friends and an excellent environment in which to conduct the business of the foundation and the association. We are most grateful for Mr. McGovern's generosity and will be pleased to name the building in his honor."



McGovern said he was fortunate to have great role models in his uncles, Glenn, Bev and Doss Hill, who all graduated from the university when it was called North Dakota Agricultural College. Glenn Hill was a long-time chair of the mathematics department and one-time head of the North Central Conference.

"My time at NDSU combined serious learning with a fun college atmosphere; North Dakota State University was perfect for me and will always be remembered as four of the best years of my life," McGovern said.

McGovern's company has constructed more than 1,500 bridges throughout California and currently has 25 projects under contract, including three projects on the new San Francisco-Oakland Bay Bridge, a \$200 million project near the port of Long Beach consisting of the removal of an existing lift span bridge and the construction of two 5,000-foot long concrete box girder bridges, and a \$50 million design-build project near Los Angeles.

The firm consistently ranks within the top 200 heavy engineering contractors in America and has received numerous awards for excellence in construction, including awards for three major interchanges in the Los Angeles area and an award for a cast-in-place segmental box girder bridge constructed over the Eel River in northern California.

The NDSU Alumni Center is a 30,520-square foot facility that has hosted a variety of alumni, campus and community events. The center's first floor accommodates Alumni Association offices, center director's office and Crary Lounge. The first-floor areas surround the center's two-story Diederich Atrium, which seats 130 people in a banquet setting. The second floor houses the Development Foundation offices, Stenehjem executive conference room, Klefstad conference room, Hendrickson Lounge and Stegner Terrace. The building was officially dedicated Oct. 8, 1999.

# WHITE HOUSE EXPERIENCE PROVES UNFORGETTABLE

It was an event NDSU alumnus Courtney Brye says he will never forget. Brye, BS '69, animal science, had a "once in a lifetime experience" of attending a White House dinner on March 14 to honor British Prime Minister David Cameron and his wife, Samantha.

Brye said he and his wife, Elaine, got the rare opportunity because they wrote a Christmas card to President and Michelle Obama, telling them about their four children now in four different branches of the military. "It must have touched the hearts of the staff who read the letter," he wrote, noting Mrs. Obama invited them to sit at the head table of the dinner for 360 people under a huge tent.

"The outdoor ceremony was held on the beautifully landscaped south lawn of the White House on a nearly perfect spring day. Not a breeze was present as the radiant sun warmed the body and the soul in a pristine surreal setting," is how Brye described the scene. "From our vantage point waiting for the arrival party, we had an unobstructed view of the Washington Monument as well as the Capitol dome. The magnolias were in full bloom and the subtle pleasant aroma of lilac blooms was in the air."

There was a strong sense of pageantry, with military bands playing national anthems of the United States and Great Britain. Following a 19-gun salute, President Obama and Prime Minister Cameron conducted a review of the troops.

Dinner, according to Brye was spectacular. "It was a class act from top to bottom with no lack of attention to detail, from the tent design to the incredible dinner menu, to the abundant and tasteful floral arrangements with a British garden theme," Brye wrote.

Brye noted that, perhaps ironically, one of the dishes served was bison Wellington from his home state. "I just thought it was special to be served a North Dakota product and have it mentioned in news releases worldwide."

Among the people the couple met were Medal of Honor recipient Sgt. Leroy Petry, Sen. Richard Lugar, businessman Warren Buffet, actor Damian Lewis, actor George Clooney and Secretary of State Hillary Clinton. "I enjoyed the target rich environment as a cameraman, but I felt a bit stymied while being seated at the head table," Brye wrote. "I took fewer pictures than I would have liked but the memory of the evening will not be soon


Brye lives in Winona, Ohio, and works as a pilot in Dhaka, Bangladesh.

# LIBRARY OF CONGRESS RECEIVES RARE GIFT

Don Homuth, BA '70, speech, donated his "Map of the Square and Stationary Earth" to the Library of Congress in Washington, D.C., during a ceremony in September 2011. The unusual map was created in 1893 by religious zealot Orlando Ferguson, and Homuth obtained it decades ago as a gift from his former eighth grade teacher, John Hildreth.

Homuth's donation received national and international media attention. His local newspaper, the Salem Statesman Journal, reported Homuth saying, "The formal presentation was great. I got the impression that the Library of Congress was most delighted with the map."

According to news stories, Library of Congress personnel searched their archives and did not have the map among its 5.2 million geographyrelated materials.



During his trip to the nation's capitol, Homuth and his wife, Kathy Cegla, took a special tour of the Library of Congress that included touching a map George Washington sketched of his farm and seeing the Bible used during the inaugurations of presidents Abraham Lincoln and Barack Obama.

Homuth notes his former teacher, Hildreth, lived three blocks south of the NDSU campus and often rented apartments to NDSU students. Homuth lives in West Salem, Ore.

# HORTICULTURE ALUMNUS CREATES BEAUTY BELOW GROUND

When David Bird heads for his "cave," he's actually going to work. And it's a vocation that produces amazingly beautiful flowers in a highly unusual spot.

Bird, BS '82, horticulture, owns Bird's Botanicals; an orchid nursery located in, of all places, the caves of an old limestone quarry. Miners once blasted out limestone to be used in cement at the Kansas City, Mo., location, but Bird has transformed the underground cavern into a virtual garden containing thousands of extraordinary orchids.

"I became interested in orchids at age 16 when my parents took my brother and me to Hawaii," said Bird, who grew up in Jamestown, N.D. "I purchased my first five Dendrobiums there, and I've been hooked ever since."

Using high-powered 1,000-watt sodium lights, a ventilation system, water supply line and an electrical transformer, Bird has created a year-round, nearly perfect growing environment. Bird's orchid business occupies about 10,000 square feet of the former quarrynow called the Interstate Underground Warehouse.

"Working in a cave is strange. The temperature is almost always the same. The lights are on from 10 a.m. to 10 p.m., so every day is sunny," Bird said. "I have five orchid rooms – blooming, growing, warm, tropical and secret."

According to Bird, orchids are something truly special. They come in every color, except black and true blue. With more than 25,000 species and 141,000 hybrids, orchids make up the largest family of blooming plants on the planet. "One out of seven flowers on Earth is an orchid. With all that diversity, I could never get bored with growing orchids," Bird said.

His fascination with orchids was clearly demonstrated while Bird was a student at NDSU. During that time, he maintained the university's orchid collection and added 300 new species and hybrids. "I did keep one plant alive from that collection for 30 years. Its name was Paphiopedilum Alfred x Dimmockii," Bird recalled.

A proud alumnus, Bird said he chose NDSU because of its strong horticulture program, and his studies

helped him solidify his career plans as a horticulturalist. But, Bird's path took a few interesting turns before he created his underground garden.

After an internship at the International Peace Garden, Bird designed the garden's famous Floral Clock during the eight years he worked there following graduation. Stops at the Des Moines Botanical Center in Iowa and a greenhouse operation in Wayne, Neb., came next. Those experiences led him to Powell Gardens

in Kansas City, a visitor center and conservatory, where he displayed his horticulture abilities for seven years. While at Powell Gardens, his personal successat orchid exhibits prompted him to start Bird's Botanicals in his spare time.

"I first built a 400-square-foot greenhouse onto my house in Blue Springs, Mo. In a year I had over 1,500 orchids and more on the way. I tried to rent additional greenhouse space, but nobody was keen to the idea," he said of his then part-time job.

One day, a stunning idea occurred to him as he drove past the Interstate Underground Warehouse. "I brought the manager a white Phalaenopsis and told him I wanted to grow orchids in his cave," Bird said.

It took about six months of experimenting, along with heating up the rock ceiling and pillars, to get conditions in the cave just right. But, the orchids eventually flourished in their underground setting.

And Bird discovered he had another important decision to make.

"Finally, the orchids won out," he said. "When I told my wife, Linda, I couldn't work all day at the Powell Gardens and half the night in the cave, I had to make a choice. She told me if I wanted to grow orchids full time I better get started. I left for Hawaii a week later and came home with a 1,000 more plants."



And Bird keeps looking for new orchids to add to his incredible nursery. "I traveled to Ecuador to collect plants, and I make frequent trips to visit growers in Hawaii and California," Bird said, noting 12 orchids have been awarded to him and two are registered, each of them named for members of his family.

His name is increasingly recognized among orchid enthusiasts. Bird and his unusual nursery were featured in the August 2011 issue of Orchids, the bulletin of the American Orchid Society. That story has sparked an influx of visitors to Bird's operation.

It's an experience he loves to share.

"This year, we added a classroom, media room and restroom to our sales room and work room," Bird said. "The future of the business is to work more garden and orchid shows, since that exposure gets more people to visit the cave. We also are trying to expand our orchid and product line with orchid shirts, jewelry and concrete containers."

If you'd like to take a look at his underground nursery, Bird's Botanicals is open to the public on Tuesdays, and Wednesdays through Fridays by appointment. And he gives tours of his "cave" nearly every week.

#### **ALUMNI ACHIEVEMENT AWARD**

Gilman Rud, BS '66, agricultural economics, and Barry Batcheller, BS '77, electrical and electronic engineering, are recipients of the Alumni Achievement Award that honors alumni who have earned distinction in their professional fields.

During his 28-year U.S. Navy career, Rud flew aerial combat missions in the Vietnam War, earned the rare distinction as commanding officer for the Blue Angels and served as commanding officer for two Navy ships. He went on to work for McDonnell Douglas Aerospace Co., which is now part of Boeing Co. He played a key role in the development of the F-18 Super Hornet, which at the time was one of the most advanced fighter planes in the world. Rud lives in Coronado, Calif.

Batcheller holds more than 20 U.S. patents and has founded four start-up companies, including Phoenix International, which pioneered the use of microcomputer controls, adaptive software algorithms and "fuzzy logic" for agricultural and off-highway control systems. He also started Appareo Systems LLC, an advanced technology business that designs and manufactures electronic, mechanical and software products for aerospace, defense and transportation applications worldwide. Batcheller was awarded an honorary doctorate from NDSU in 2010. He lives in Fargo.

#### HENRY L. BOLLEY ACADEMIC **ACHIEVEMENT AWARD**

Marvin J. Miller, BS '71, chemistry, is the recipient of the Henry L. Bolley Academic Achievement Award that recognizes alumni who have attained achievements in academia as instructors, researchers or administrators.

Miller serves as the distinguished George and Winifred Clark Chair of the chemistry program at University of Notre Dame. Among his accomplishments are 269 publications, 22 patents, 142 papers presented and 201 invited lectures. 

# GOLFER ANDERSON EARNS RECOGNITION

The list of honors and accolades for Bison women's golfer Amy Anderson is growing longer.

Anderson, an accounting major from Oxbow, N.D., was named the 2011-12 Summit League Scholar-Athlete of the Year, which is the most prestigious individual honor given by the league. She also was selected for her third straight NCAA tournament, voted to the Capital One Academic All-America first team and received the Dinah Shore Trophy Award from the LPGA Foundation for her academic accomplishments, athletic achievements, leadership and community affairs.

In addition, Anderson was the Summit League championship Most Valuable Player and individual champion for the second straight year.

Anderson continued her wonderful play this summer. She had a second-place finish in the World University Golf Championship in the Czech Republic, and she was a member of Team USA at the Curtis Cup, a competition that pits the United States against Great Britain and Ireland.

Anderson and Bison teammate Sarah Storandt were named to the National Golf Coaches Association's All-American Scholar Team.
Anderson was selected for the third straight season. Storandt, a freshman from Moorhead, Minn., is majoring in mathematics education.

### BISON SOFTBALL TEAM HAS OUTSTANDING SEASON

It was another season of success for the Bison softball team. The squad, which has won The Summit League tournament four straight years, competed in the NCAA tournament for the fourth consecutive year.

NDSU finished the season with a 38-22 record, matching the school record for wins at the Division I level. The 2009 Bison team finished 38-20.

At the NCAA Tucson Softball Regional at Hillenbrand Stadium, the Bison lost an opening round game to eight-time national champion University of Arizona, but the team rallied to defeat the University of Hawaii by a score of 9-7. The season ended with an 8-4 elimination game loss to the University of Notre Dame.

Junior Whitney Johnson from Lake Crystal, Minn., also pitched a no-hitter this season for the Bison. Her outstanding performance came in the second game of a doubleheader vs. the University of Missouri-Kansas City on April 21, the program's 22nd no-hitter.


## BASEBALL TEAM HAS RECORD-SETTING YEAR
