#### **NARRATIVE REPORT**

#### 1.0 **BUILDING INFORMATION**

Morrill Hall was originally constructed in 1922; a 1930 addition extended the building to the northwest. The building has had several renovations; notably, a 1981-1985 multi-phase renovation throughout the basement, 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> floors.

Morrill Hall is a four-story, 62,166 ft<sup>2</sup> building which primarily serves as office areas and classroom areas. Hultz Hall (A026) is attached via a skyway on the north side of Morrill Hall and is reported separately. The skyway is included in the Hultz Hall report.

The interior floor finishes included carpet, floor tile, ceramic tile, concrete, terrazzo, sheet vinyl flooring, and linoleum; the interior wall finishes included gypsum wallboard, wood, plaster, ceramic tile, concrete block, and brick; and the interior ceiling finishes included ceiling tile, gypsum wallboard, plaster, and concrete. The roofing system is a peaked clay shingled roof and the exterior of the structure is brick.

The piping systems were insulated; fiberglass insulation (both with and without hard fittings), millboard insulation (without hard fittings), and mag block insulation (with hard fittings) are located in the building. Steam enters the building in room 12A and domestic water enters the building in room 11. HVAC systems located in the building consisted of steam radiators and forced air furnaces equipped with heating/cooling coils.

#### 2.0 **ASBESTOS SURVEY INFORMATION**

Morrill Hall was surveyed as part of a larger project on NDSU's Fargo, ND Campus. This report is part of "Volume 3" of a nine volume series. This report includes building specific information only; please refer to the opening section of "Volume 3" for methodologies, definitions, and other pertinent supporting information.

A total of 191 samples were collected from suspect asbestos-containing materials (ACM) from Morrill Hall on July 13, 2007, an additional 9 samples were collected on December 12, 2007, and an additional 1 sample was collected on December 27, 2007. Laboratory analysis results indicate 33 of these samples tested positive for asbestos.

<sup>\*</sup> The floor filler materials used under the carpet on 1<sup>st</sup> floor contain asbestos. The carpeting on 1<sup>st</sup> floor is installed over older ACM flooring. The floor filler materials should be abated with the older ACM flooring when the carpet is to be removed.

#### 2.4 Survey Notes

During the 1981-1985 renovations, carpet was installed in many of the rooms in the building over the flooring that was previously present. At the time the carpet was installed, a floor filler material was used to level the floor. Due to the limited access to the materials below the carpet and the presence of floor filler in those areas where the materials were accessible, LEGEND attempted to define homogeneous areas based on the color and consistency of the concealed flooring materials. After homogeneous areas were identified, LEGEND collected multiple samples of each homogeneous area. All samples of suspect flooring materials (excluding concrete and terrazzo) under carpet in the building were positive for asbestos. Any material found under the carpet in the building, even if it does not exactly match the material description provided by LEGEND, is an ACM.

LEGEND identified brown carpet mastic installed over residual black mastic in several areas of the basement (identified as brown/black carpet mastic). Prior to the 1981-1985 renovations in the building, the basement was flooded by a water main break. LEGEND assumes the flooring in the basement prior to the renovations was loosened by this flood and removed, however, it appears the mastic was left and carpet mastic was applied directly over it. LEGEND identified these areas by pulling back the carpet in several corners in each room and inspecting for the residual black mastic. If none was observed, LEGEND did not consider the room to have the residual black mastic under the carpet. It is possible that residual black mastic may still exist under the carpet in these rooms in areas LEGEND was unable to inspect (such as in the middle of the room). LEGEND recommends assuming all carpeted areas in the basement to have ACM residual black mastic until a destructive survey can be conducted for a final visual verification under the carpet. The surface area of the remaining carpeted rooms in the basement is approximately 2,500 ft<sup>2</sup>.
