NARRATIVE REPORT

1.0 **BUILDING INFORMATION**

Music Education was originally constructed in 1982; although specific information could not be located, small renovations are evident.

Music Education is a four-story, 82,204 ft² building which primarily serves as classroom and office areas for performing arts personnel. Minard Hall (A021) is attached to the east side of Music Education and is reported separately.

The interior floor finishes included carpet, concrete, floor tile, wood, and epoxy flooring; the interior wall finishes included gypsum wallboard, concrete block, concrete, ceramic block, brick, and plaster; and the interior ceiling finishes included ceiling tile, wood, gypsum wallboard, plaster, metal, and concrete. The roofing system is a flat rubber-membrane roof and the exterior of the structure is brick.

The piping systems were insulated; fiberglass insulation (without hard fittings) is located throughout the building. Steam enters the building via a tunnel in room 4 and domestic water enters the building in room 4. HVAC systems located in the building consisted of steam radiator and forced air furnaces equipped with heating/cooling coils.

2.0 **ASBESTOS SURVEY INFORMATION**

Music Education was surveyed as part of a larger project on NDSU's Fargo, ND Campus. This report is part of "Volume 2" of a nine volume series. This report includes building specific information only; please refer to the opening section of "Volume 2" for methodologies, definitions, and other pertinent supporting information.

A total of 61 samples were collected from suspect asbestos-containing materials (ACM) from Music Education on August 21, 2007 and an additional 7 samples were collected on May 9, 2008. Laboratory analysis results indicate **12** of these samples tested positive for asbestos.

2.4 Survey Notes

LEGEND identified and sampled 2 types (homogeneous areas) of Encapsulant on Fiberglass Insulation in Music Education; an original vintage that was installed in 1982 construction of the building and a newer replacement "bright white" vintage that has been installed since the 1982 construction. The original vintage tested positive for asbestos and the newer replacement "bright white" vintage tested negative for asbestos. LEGEND visually quantified the original vintage encapsulant on fiberglass insulation throughout the building and included this information in the ACM Locations Diagrams and Tables. In addition, LEGEND identified and sampled Hard Pack on Fiberglass Insulation in Music Education; it tested negative for asbestos.
