GREETINGS FROM OUR DIRECTOR



Reflecting on the 2024-2025 academic year, I'm proud of our accomplishments. The sixth year of the Challey Institute for Global Innovation and Growth has been our most successful. We've increased academic publications and policy-relevant research, impacted more students, expanded outreach, and informed more policies.

Our interdisciplinary team addressed many key policy issues last year, including alleviating rural physician shortages, leveraging immigrants for worker shortages, enhancing police well-being, highlighting the role of multilateral institutions in trade, increasing supply chain resilience, and identifying the impact of R&D taxation on innovation.

As a result of our research and media efforts, we achieved tangible results last year, influencing several policy actions. For instance, after studying food insecurity in North Dakota and media outreach, the Legislature allocated \$10 million for a new food distribution facility. Our work on Al-related energy infrastructure led to a North Dakota Pipeline Authority plan for a 10-year credit line to support natural gas movement to eastern North Dakota, powering Al. Additionally, our efforts informed debates on school choice, occupational licensing, business climate on reservations, and property tax reform.

Our events team held successful events for students, faculty, staff, and the public. The Menard Family Distinguished Speaker Series featured thinkers like Greg Lukianoff, who discussed the speech crisis on campuses, and Robert Zoellick, who talked about America's global role. The Human Progress and Flourishing Workshop included scholars on entrepreneurship, education, health care, Al, the workforce, and land-use. These events drew 2,000 attendees.

Many students were impacted by our programming, including those pursuing a private enterprise certificate, reading groups on a wide variety of issues, a pluralist lab for meaningful conversations, and interdisciplinary graduate students aligning research with opportunity and flourishing.

Looking ahead, I couldn't be more excited! We have a strong team committed to continuing policy-relevant research, amplifying our results, providing meaningful programming for students and the community, and working toward our vision of 'a world where economic opportunity and flourishing are available to all.'

I truly appreciate our donors and partners for making this work possible. Your generosity is having a wonderful impact on the lives of our students, community, and beyond. We are committed to working hard to continue earning your trust and support.

The Sheila and Robert Challey Institute for Global Innovation and Growth was launched at North Dakota State University in 2019. The Institute is named in honor of Sheila and Robert Challey (NDSU '67), who provided the leadership gift to establish the Institute. The Institute received the largest collection of philanthropic support focused solely on faculty and student scholarship in NDSU's history. This transformative gift established an interdisciplinary institute dedicated to student programming, research, and outreach.

IMPACT >

FOOD INSECURITY IN NORTH DAKOTA

The Challey Institute's report Food Insecurity in North Dakota found that 8.5% of residents struggle with access to affordable, nutritious food, with rural communities facing unique challenges from distance and cost. The study drew coverage across local and state media, raising awareness among policymakers and community leaders. Combined with outreach efforts, the research helped shape the passage of HB 1143, which provided \$10 million toward a new food distribution facility that will serve North Dakotans for decades.



POWERING AI IN NORTH DAKOTA

In January 2025, Dr. Robert Mayo published North Dakota Natural Gas Can Power the Artificial Intelligence Revolution, which outlined how the state's natural resources and climate could attract next-generation Al data centers. The research gained wide attention through media coverage, an op-ed, and radio interviews, and it was later discussed in meetings with Congresswoman Julie Fedorchak. By spring, state officials were advancing proposals for new natural gas pipelines, with legislators echoing the report's themes in formal discussions—demonstrating how the work shaped a statewide conversation about Al and energy.

SCHOOL CHOICE IN NORTH DAKOTA

Dr. Patrick Wolf's paper What School Choice Could Do for North Dakota analyzed how education savings accounts (ESAs) could expand learning opportunities, drawing on decades of national research. Featured in the Fargo Forum and covered by KFYR-TV, the report provided legislators and the public with critical data during a pivotal policy debate. While Governor Armstrong ultimately vetoed the bill, citing rural access challenges, the Challey Institute's work ensured the discussion was grounded in evidence about how school choice might impact North Dakota families.



IMPACT



OCCUPATIONAL LICENSING REFORM

In February 2025, Nicholas Orlando released Reforming Occupational Licensing in North Dakota, which detailed how burdensome requirements contribute licensina workforce shortages. His recommendations for universal license recognition were widely shared through media, including an op-ed in the Fargo Forum. Soon after, lawmakers passed and Governor Armstrong signed legislation establishing universal recognition, allowing qualified professionals licensed in other states to begin working immediately in North Dakota—demonstrating a direct link between Challey Institute research and policy reform.



PROPERTY TAXES AND LOCAL GOVERNANCE

Dr. James Caton's Property Taxes and Budgetary Independence in North Dakota provided timely analysis of a ballot measure that sought to eliminate most local property taxes. The report estimated the state would need \$3.15 billion in replacement revenue every two years and outlined risks to local control and fiscal stability. Covered across radio and print outlets statewide, the research offered voters a clear, evidence-based perspective on the trade-offs involved, playing a central role in shaping an informed debate before the measure's defeat at the ballot box.



BUSINESS CLIMATE ON RESERVATIONS

Dr. Thomas Stratmann's Enhancing the Business Climate and Incentivizing Business Development on North Dakota Indian Reservations examined how history, regulations, and institutional barriers shape economic opportunity in Native communities. In October 2024, Stratmann presented his findings to the North Dakota Tribal and State Relations Committee, which included state legislators and the Standing Rock Sioux Tribal Council. The testimony was praised as valuable and informative, helping to frame conversations on how policy can reduce barriers, encourage entrepreneurship, and attract investment in tribal communities.

Reading Groups

The Pluralist Lab

The Pluralist Lab aims to bring together a diverse group of students to engage in discussions about controversial issues. They learn to practice reflective listening and to engage in meaningful conversations with people with whom they disagree.

We hosted two joint pluralist lab with Concordia College, which included 18 students in both the Fall and Spring semesters.

Certificate Program in Private Enterprise

The Certificate in Private Enterprise is a 9-credit certificate program that: (1) introduces students to the fundamentals of business and economics, (2) helps students to understand the differences between different economic systems (socialism and capitalism) and their implications, (3) gives students an appreciation for the positive role that entrepreneurs and businesses can play in society, and (4) engages students in discussion and critical thinking surrounding important societal issues. The program has expanded to 46 students in only its second year.



GREG LUKIANOFF

Greg Lukianoff, president of the Foundation for Individual Rights and Expression, delivered Free Speech in Free Fall: The Academic Freedom Crisis on Campus. He examined the rise of cancel culture in higher education, its consequences, and possible solutions, followed by a discussion with Menard Family Director John Bitzan and audience Q&A. The event drew strong engagement, with 100 copies of his book The Cancelling of the American Mind distributed.



DOUG DUNCAN

Douglas Duncan, former Chief Economist at Fannie Mae, joined the Menard Family Distinguished Speaker Series in Bismarck to discuss the U.S. economy and its implications for North Dakota. In conversation with Menard Family Director John Bitzan, he addressed inflation, interest rates, housing, technology, and structural changes since the pandemic.

POLICY RESEARCH

PUBLICATIONS BY CHALLEY STAFF. FELLOWS. AND SCHOLARS HOUSED ON OUR WEBSITE

Addressing the Physician Shortage in North Dakota, Robert Mayo (June 2025) North Dakota ranks 37th nationally in patient-to-physician ratios, with shortages most acute in rural areas where 48 of 53 counties lack adequate coverage. Without action, the state could face a deficit of 500 physicians by 2040, which would threaten access to essential services and the sustainability of rural hospitals.

Policing, Mental Illness, and Seeking Help: Perceptions of Stigma, Carol Archbold, Ph.D. (May 2025) This study explores police officers' perceptions of mental illness and the stigma surrounding it, which can discourage them from seeking help. It also examines their awareness and use of workplace wellness programs and services.

Reforming Occupational Licensing in North Dakota, Nicholas Orlando (February 2025) With a tight labor market, North Dakota struggles to attract workers across many fields. Reducing or removing licensing restrictions could expand the workforce at little cost.

More Prairie Prosperity: Economy and Fiscal Policy in North Dakota, James Caton (February 2025) This report highlights North Dakota's strong labor market, low unemployment, and high income while warning of persistent labor shortages and reliance on state transfers. It also considers fiscal and policy choices that could strengthen growth.

What School Choice Could Do for North Dakota, Patrick J. Wolf (February 2025) As the only state without charter schools or private school choice, North Dakota stands apart from most of the nation. This paper examines how a universal ESA program could expand options for families and affect taxpayers.

Utilizing TN Status to Attract Workers to North Dakota, Jiawei Liu (January 2025) North Dakota's severe worker shortage could be eased by greater use of the TN visa program, which allows Canadian and Mexican professionals to work in the U.S. Current licensing restrictions and limited eligible occupations, however, reduce its effectiveness.

North Dakota Natural Gas Can Power the Artificial Intelligence Revolution, Robert L. Mayo (January 2025) Al data centers require massive physical and economic resources, creating opportunities for North Dakota. This paper outlines benefits and offers five policy recommendations to attract investment.

Food Insecurity in North Dakota, Ethan Liu (November 2024) This research examines the barriers to affordable, nutritious food and the impacts on health and well-being.

Property Taxes and Budgetary Independence in North Dakota, James Caton (October 2024) The proposed elimination of property taxes could fundamentally reshape state finances and local governance. This report analyzes the tradeoffs for fiscal policy, public services, and economic stability.

2024 American College Student Freedom, Progress and Flourishing Survey, John Bitzan (August 2024). The annual survey by the Challey Institute tracks how college students view free speech, viewpoint diversity, human progress, and economic systems like capitalism and socialism.
