SUBJECT: State Fleet Services Rental Rate Adjustment

Dear Fleet Users,

State Fleet Services is pleased to provide our quarterly update on vehicle rental rates.

We have completed our review and adjustment process to reflect the most recent costs of operation. The new rates are effective **December 1, 2025**, and are attached for your review.

### **Price Stability in a Changing Environment**

We are proud to report that our proactive fleet management strategies have resulted in remarkable price stability for most vehicle groups this quarter.

Despite fluctuations in underlying costs, our effective strategies have allowed us to maintain rental rates that closely mirror the previous quarter. This stability is the result of two major trends:

- **Improved Efficiency:** Higher fleet utilization this quarter has driven down operating rates across most vehicle groups, a direct result of your continued partnership and efficient scheduling.
- Strategic Investment: We are continuing our necessary cycle of fleet renewal by introducing newer, safer, and more reliable inventory. While this introduces higher depreciation costs compared to older, fully depreciated vehicles, the strategic investment ensures we maintain a high-quality fleet capable of supporting your agency's needs.

#### **Expected Impact on Your Vehicle Rates**

 Motor Pool Vehicles: The decrease in operating rates is largely offset by the increase in depreciation per mile. The net result for most groups is an impressive near-zero change, ensuring minimal impact on your motor pool budget.





• **Assigned Vehicles:** You should continue to see a slight decrease in your overall rate per mile or hour due to lower operating costs, while your fixed monthly depreciation will increase with the assignment of newer, high-value inventory.

We encourage you to examine the attached document to understand the minimal changes within your specific vehicle groups.

To ensure we continue to maintain a safe, well-running, and highly utilized fleet, please continue to proactively schedule all required preventative maintenance on your assigned vehicles.
