**SELECTED ADMINISTRATIVE AND LEADERSHIP EXPERIENCES**

*Extracted and expanded from CV.*

***Interim President, Utah State University*** (February 2025 – November 2025)

*General Responsibilities* – Led the public land-grant institution of the state of Utah, an R1 (Doctoral Universities – Very high research activity) designated university that serves over 28,000 students at its main campus in Logan and numerous statewide locations. The University has revenues exceeding \$1.2B annually and employs over 1,100 academic staff and 11,000 total staff. Responsibilities included oversight of all functions of the university, external-facing responsibilities including government relations and fundraising, navigating our accreditation renewal with the Northwest Commission on Colleges and Universities, planning for and communicating about a significant budget reallocation that involved both cuts and new investments, promoting a forward-looking agenda that met the long-term needs of the institution and the well-being of the people who comprise it, and providing stability and a foundation for the success of the next President.

***Selected Achievements***

- **Budget and Strategic Management:** Oversaw a \$4.8M budget cut and the development of a strategic reallocation plan redirecting \$12.6M of state instructional funds from underperforming programming toward efforts in technology and future workforce needs, health and well-being, and student success. This will result in new undergraduate majors (e.g., behavioral neuroscience, chemical engineering), expansion of programming and scholarship in areas like AI, energy engineering, and dementia care, and enhanced supports for students at all levels from technical education through doctoral study. The plan involved merging five colleges into two colleges, which generated synergies that attracted \$10M in gifts to endow a directorship and deanship, respectively, and \$500k ongoing dollars from the Utah legislature to reconstruct general education to offer common student experiences and civic education. Careful planning and a voluntary separation incentive program enabled us to limit need for reduction in force actions. Campus climate challenges were mitigated through iterative engagement with academic leaders, inviting feedback from our broader campus community, and direct and extensive public communications from me about decision-making. The plan was approved through the USU Board of Trustees, Utah Board of Higher Education, and the Higher Education Appropriations subcommittee of the Utah legislature, with final approval contingent upon review and presentation to the Utah Executive Appropriations committee by the permanent President. All disinvestment work moved forward during my tenure and core reinvestments are commencing.
- **Athletics:** Finalized our long-form agreements for joining the Pac-12 athletic conference, items tied to our separation from the Mountain West athletic conference, and planning work for the re-launch of the Pac-12 (which included decision-making on our business model, personnel, conference expansion, media rights negotiations, and other matters). Renegotiated head men's basketball coach contract, hired interim director of athletics and supporting deputy from outside of the institution, and hired permanent director of athletics following an intensive national search. Developed an ad hoc advisory committee to engage the broader community (student-athletes, coaches, staff, alumni, donors, community leaders, legislators) in developing job criteria and recommendations for the new athletic director, creating a unified perspective and commitment to supporting that leader's success. Engaged donors in our \$125M Reach and Rise Campaign for USU Athletics through public events and private engagement.
- **Accreditation:** Completed late-stage work associated with the site visit and commission visit tied to our Northwest Commission on Colleges and Universities accreditation renewal. We received high praise, with two commendations and four recommendations that tightly align with our ongoing efforts.
- **Personnel and Leadership Transition:** Addressed wages of our lowest paid workers, elevating 6% of our workforce to living wage or salary grade midpoint for entry level positions (now met by 94.5% of USU employees). Worked to clear backlog of personnel/legal items, fill or reconceptualize key positions, address market competitiveness for leadership roles, meaningfully engage students, staff, and faculty, and advance relationships with external stakeholders to ensure a seamless transition for the permanent President (by Utah code, an interim president may not pursue the permanent role).
- **Received praise from the Board of Trustees, state officials, alumni, community members, faculty and staff, and students for offering a steadying hand, providing transparent communication, maintaining a forward-looking perspective, and actively advancing initiatives during a challenging period for the university and higher education.**

***Dean, Emma Eccles Jones College of Education and Human Services, Utah State University (2021 – present)***

*General Responsibilities* – Lead the largest college at Utah State University, which serves roughly 4,500 undergraduate majors and 850 graduate students at the Logan and Statewide campuses. The College had FY24 revenues of over \$110M and employs over 200 full-time faculty and 300 full-time staff as well as roughly 600 part-time workers. The College houses 8 academic departments, 5 significant research/service centers, a number of special programs and services, and an elementary school. Offer strategic direction and oversight for the College, including its broad academic programming, significant grant and contract portfolio (over \$52M expenditures annually), and engagement with institutional and external parties. Support the development of high-performing faculty and staff, foster student success, advance a culture of inclusive excellence, and align College activities with institutional goals and initiatives. Lead College executive team, which includes associate deans, heads of academic units and centers, and heads of business services, strategic communication, technology, and development/fundraising. Serve as member of university executive team responsible for implementation of institutional strategy. Cultivate positive relationships with state bodies, professional organizations, legislators, alumni, donors and others to ensure the College is well positioned as a go-to partner for knowledge/expertise, to have access to important learning and research contexts, to secure financial resources, and to attain national recognition.

***Selected Achievements***

- **Strategic Growth:** Pursued cluster hires in health/education disparities and health and technology, engaging expertise and leaders across campus. Developing and implementing a health and human science initiative to foreground health within our college, introduce new programming (e.g., behavioral neuroscience, substance abuse and addiction), coordinate campus public health offerings, and reenvision units to best meet future educational needs, with emphasis on workforce readiness *and* resilience.
- **State Resourcing:** Secured \$850k ongoing state monies to institute an Alzheimer's Disease and Dementia Research Center, \$1M+ one-time monies to support clinical mental health services and embedding of teacher education students in partner school districts, and \$400k+ ongoing monies to pursue new faculty hires through healthcare workforce initiatives.
- **Development/Fundraising:** Completed fundraising for \$4.5M facilities project to expand our nursing program, secured \$975k for pilot program to support early-career K12 teachers in Utah, formalized agreements and expanded funding commitment for endowed deanship and four professorships, and secured commitment to add a third development officer to our College team, which raised about \$2M in FY23, \$2.5M in each of FY24 and FY25, and have exceeded \$4M in the first half of FY26.
- **Student Success:** Implemented consistent graduation GPA requirement across the College to reduce student challenges with degree completion, adjusted grant proposal policy to ensure robust support of graduate research assistants, revitalizing EdD program and encouraging 4+1 and streamlined master's programs, and pursuing new programming and micro-credentials.
- **Inclusive Excellence:** Instituted Associate Dean role tied to faculty development, promotion and tenure informational sessions across position types and ranks, formalized search and screening committee guidelines to reduce bias in search processes and secure more competitive applicant pools, and transparency of service work in academic departments. Formed a task force group that provided a report on the college climate and actionable recommendations to foster inclusive excellence.
- **Research Infrastructure:** Instituted Associate Dean role tied to innovation and tech transfer, formed a Research Infrastructure task force that provided a report on college needs, revised model for return of indirect costs to the College to enable further investment in research capacity, secured additional proposal development specialist, and instituted program for guided development of federal grants. Grant expenditures have increased over my tenure from \$37.1M annually to \$52.6M annually.
- **Shared Governance:** In highly decentralized context, have developed shared understandings and policies across units, worked to offer transparency in fiscal and other matters, instituted a faculty advisory committee, and have pursued other strategies to advance a culture of shared governance.
- **Recognition:** Instituted eNewsletter that showcases our accomplishments and is distributed nationally, hired new communication director to focus on strategic communication of our accomplishments, engage regularly with school superintendents and state legislators to share our accomplishments and offer our support, meet monthly with Deans of Education in Utah (as Chair in 2024-2025), and tasked Associate Dean and Department Heads with nominating our faculty for national awards and fellow recognition.

***Chairperson, Department of Kinesiology, Michigan State University (2012 – 2021)***

*General Responsibilities* – Led academic unit serving nearly 1300 undergraduate majors and 125 graduate students with 18 tenure-track faculty, 4 fixed-term faculty, 4 support staff, over 30 part-time instructors, and over 40 graduate teaching assistants. Implemented research, learning, and service/outreach missions of the department, ensuring alignment with missions of the College of Education and Michigan State University. Fostered immediate- and long-term health of the unit through advocacy and formation of strategic partnerships. Managed fiscal, space, and other resources in support of department mission. Recruited, hired, and supported the development of high-performing faculty and staff. Supported the development of outstanding students. Served on leadership team of the Dean of the College of Education. Represented department nationally and with peer institutions.

***Selected Achievements***

- Completed program review and planning process in my first year, producing unit strategic priorities.
- Guided substantial transition of personnel, hiring over half of the faculty and staff within my first four years with emphasis on collaborative and research funding potential (number of tenure-line faculty grew from 13 to 18 over my tenure as chair).
- Advanced climate of inclusive excellence through more deliberate structure in search processes, recognition of a diverse array of alumni (with respect to personal background and professional work), commitment to adaptive sports, broader representation of employers in our annual career event, transparency of faculty service work, and other initiatives.
- Developed *Cognitive and Motor Neuroscience* emphasis area in the department, tied with several new hires, construction of 2700 square feet of equipped lab spaces (completed winter 2014), and construction of a 1500 square foot faculty office suite (completed fall 2016).
- Expanded *Athletic Training/Sports Medicine* emphasis area by securing support for constructing and equipping a 900+ square foot athletic training research lab space (completed fall 2015), partnerships with Athletics and the College of Medicine to hire two additional tenure-line faculty (in 2019 and 2020, respectively), initiation of a MS in AT professional degree (first cohort summer 2020), and securing support for 1500 square feet of additional office and lab space (completed fall 2020).
- Secured support to develop a 1250 square foot neonatal nutrition and exercise research lab space to accommodate animal-based work in our *Exercise Physiology* emphasis area (completed fall 2015).
- Secured \$270,000 of competitive internal equipment funds and support for constructing a 1500 square foot teaching space tied to instructional labs for athletic training, introductory kinesiology, and a new principles of human movement course (completed fall 2016).
- Completed various other renovation projects to offer a motivating and functional work context.
- Secured support for and completed a strategic hire enabling department to pursue international initiatives in alignment with institutional efforts on the African continent (fall 2016).
- More than doubled external grant submissions and cultivated development of a young faculty group that had multiple proposals funded by the NSF, NIH, and other funders.
- Instituted department seminar series to support opportunity for collective intellectual exchange.
- Instituted new online MS in *Coaching and Leadership* program (1<sup>st</sup> cohort began May 2016) and other online instruction that expanded annual online income to the department (from \$100,000 to \$500,000).
- Reviewed and adjusted undergraduate course sections and cognates to reduce ‘bottlenecks’ that interfered with timely degree progress.
- Revised staff responsibilities/structure to offer more effective student support, pre- and post-award support, and overall fiscal management.
- Actively engaged in development efforts, including pursuit and receipt of annual gift, endowment, planned gift, and professorship monies that supported students, faculty, and department events.
- Excellent annual reviews from the Dean and excellent five-year (reappointment) comprehensive performance review, with the following common themes: strong vision and advocacy for the department, collegial and collaborative, supportive, willing to listen, and integrity.

***President, American Kinesiology Association (2019 – 2021)***

*General Responsibilities* – Provided leadership for organization of ~150 kinesiology departments at associate-granting through doctoral-granting institutions. AKA promotes and enhances kinesiology as a unified field of study through advocacy efforts and support of member departments by providing resource materials and leadership and educational opportunities for kinesiology administrators. Presided at executive committee, steering committee, and other meetings. Chaired annual workshop committee, oversaw program submission and review process, invited guest speakers, edited a journal special issue based on the workshop, authored newsletter articles and other communications, liaised with other kinesiology organizations and initiatives, oversaw work of business manager and publication director, oversaw award and leadership nominations, and reinforced committee efforts to advance the AKA strategic plan.

***Selected Achievements***

- Implemented initiative to form an *Undergraduate Education Network* and a *Graduate Education Network*, designed to bring together undergraduate and graduate program leaders, broaden the span of emerging leaders engaged with AKA and the annual workshop, and generate spaces for advancing future initiatives (e.g., on representation within programs, instructional space needs).
- Advanced social media presence of AKA.
- Initiated review of organizational structure following departure of Executive Director.
- Developed negotiation strategy to adjust workshop hotel contract and pivot to virtual workshop.
- Organized and implemented annual workshop (virtual, due to COVID-19).
- More broadly engaged our Inclusive Excellence Committee in annual workshop program.
- Co-Edited two special issues of *Kinesiology Review* based on 2020 and 2021 annual workshops.

***Secretary/Treasurer, National Academy of Kinesiology (2018 – 2020)***

*General Responsibilities* – Oversaw finances, membership, and meeting documents for honorary organization of 165 active fellows who have significantly contributed to the science and art of kinesiology. Reported income and expenses to membership and oversaw financial transactions completed by business manager. Served as member of executive committee. Kept executive committee and full-membership business meeting minutes.

***Selected Achievements***

- Updated financial reporting for greater clarity and accuracy, uncovering substantial annual deficit.
- Developed multifaceted strategy for addressing annual financial deficit.

***President, North American Society for the Psychology of Sport and Physical Activity (2012 – 2015)***

*General Responsibilities* – Provided leadership for academic society of ~500 members. Presided at society and executive committee meetings. Reviewed and updated policies. Administered award and recognition programs for student and professional members. Communicated with membership via newsletter articles and direct exchanges. Represented the society to external bodies, including sponsors, contractors, and other organizations. Chaired program committee, oversaw abstract submission and review process, invited guest speakers, produced and distributed final program, and supervised execution of annual conference during final year of term.

- Implemented initiative to address needs of mid-career members, leading to expanded recognition opportunities and pre-conference workshop and networking session addressing research funding.
- Revised contract with vendor that provided membership management, communication, and publication services to the society, yielding substantial savings by moving to online annual abstract supplement.
- Fully reviewed and updated policy manual to bring in line with current practice.
- Moved executive committee to address our accounting model and projected financial needs.
- Executed highly successful annual conference, with over 460 attendees, extensive international representation, and participation by high-profile keynote speakers and NIH program officer.

Marketed program, fielded inquiries, and presented program to HK undergraduate students and other groups (e.g., CIC Kinesiology Diversity Summit). Reported on program activities and products internally (e.g., HLC self-study) and externally (e.g., National Academy of Kinesiology). Coordinated provision of graduate student awards, advised the HK Graduate Student Organization, and worked with students to overcome challenges to degree progress. Mentored faculty on graduate advising matters. Served on administrative team of the Department Head.

- Initiated review of PhD qualifying examination and preliminary examination processes, leading to a fully revised model for PhD education in the department.
- Instituted formal process for annually reviewing PhD student progress.
- Intensified oversight of admissions process and progress to degree.
- Intensified emphasis on procuring research and fellowship funding to support graduate students.
- Revised web site content to better market graduate program.

***Director, Purdue University Sport and Exercise Psychology Laboratory (1999 – 2012) and Social & Motivational Processes in Physical Activity Laboratory (2012 – 2021)***

*General Responsibilities* – Oversaw research activities of sport and exercise psychology group, including about six graduate students and eight to ten undergraduate students per year. Organized meetings, journal club, and other professional development opportunities for doctoral and advanced MS students.

- Completed numerous community-based investigations examining issues surrounding quality sport experiences, physical education motivation, and benefits of physical activity for children and adolescents.
- Collaborated with pedagogy, clinical psychology, motor control, neuroscience, and public health experts.
- Conducted project funded by US Department of Education in collaboration with local school district, county health department, and physical education pedagogy group that involved 3 funded graduate students, 12 other graduate students, 12 undergraduate students, and 4 faculty over a three-year span.

Served on social and behavioral science review committee for full applications to the board. Served on executive committee and worked with office staff.

- Initiated discussions of academy mission and undergraduate sport psychology content guidelines for courses taught to physical education teaching majors.

*General Responsibilities* – Provided sport psychology services to Purdue intercollegiate athletic teams, coaches, and student athletes. Supervised graduate students serving as mental skills training consultants. Reported activities monthly to Director of Athletics. Services included individual consulting as well as team presentations addressing topics such as competition preparation, goal setting, energy regulation, imagery, group processes, confidence, self-awareness, and time management.

*Selected Achievements*

- Increased yearly services from 450 hours to 1400 hours over my tenure.
- Increased staff from 2 to 5 individuals, with graduate student support increasing from .25 to .75 FTE.
- Instituted collaborative service model with kinesiology students and a professional psychologist.
