• Eureka school district enrollment remained unchanged between 2000-01 and 2001-02, but experienced a 6 percent loss in 2002-03. The number of high school graduates varies with class size but was relatively stable over the past three years. There were no high school dropouts between 2001-02 and 2002-03.
