INTRODUCTION

A generalizable survey was conducted of residents in Moorhead, Minnesota in June 2005. The survey was developed by staff at the North Dakota State Data Center in cooperation with Clay County Public Health and other cities and counties in Minnesota who have adopted nonsmoking ordinances. The study was conducted to determine residents' views concerning the smoking ordinance that took effect in Moorhead in December of 2004, which prohibits smoking in all indoor workplaces, including offices and restaurants, but excludes bars. A similar ordinance was enacted in Fargo, North Dakota also in December 2004. The results of this study will give policy makers insight into residents' perceptions, opinions, and attitudes regarding the ordinance along with issues pertaining to smoking and secondhand smoke. A total of 360 respondents completed the survey. The study was conducted by staff at the North Dakota State Data Center at North Dakota State University.

The survey results and data tables are listed below followed by the survey instrument.

SURVEY RESULTS

Perceptions of whether smoking is allowed at various locations in the Fargo/Moorhead area

REFERENCE TABLES 1 and 1a.

- The vast majority of respondents said smoking is currently prohibited in restaurants that DO NOT serve alcohol (85.3 percent).
- Slightly more than one in two respondents (52.5 percent) said smoking is currently prohibited in restaurants that DO serve alcohol. Similar proportions of respondents, nearly one in four, said smoking is either allowed, or they were not sure (22.5 percent and 23.1 percent, respectively).
- Nearly three in four respondents (73.6 percent) said smoking is allowed in bars or cocktail lounges; one in 10 said it is prohibited (9.4 percent), and nearly two in 10 respondents said they were not sure (16.7 percent).
- Similar proportions of respondents, approximately four in 10, said smoking is either currently
 prohibited in bowling alleys, or they were not sure (43.6 percent and 39.2 percent, respectively).
 Nearly two in 10 respondents thought smoking is currently allowed in bowling alleys (16.9
 percent).
- The vast majority of respondents said smoking is currently prohibited in offices (87.8 percent).
- Respondents had mixed perceptions regarding smoking policies at outdoor patio areas of restaurants and bars. Nearly six in 10 said smoking is allowed and one in three said they were not sure (58.1 percent and 32.5 percent, respectively).

Moorhead smoking ordinance

REFERENCE TABLES 2-6.

 More than eight in 10 respondents CURRENTLY favor or strongly favor Moorhead's smoking ordinance compared to six in 10 respondents who favored or strongly favored the ordinance BEFORE it took effect in December (81.7 percent and 62.5 percent, respectively).

- Nearly two in three respondents said they somewhat closely followed the smoking debate before the ordinance went into effect (64.4 percent). More than one in 10 respondents said they followed the smoking debate very closely (14.2 percent).
- While approximately one in four said the Moorhead ordinance is not restrictive enough (25.6 percent), nearly six in 10 said the ordinance is just right (57.8 percent).
- More than one in two (51.4 percent) said stand-alone bars should not continue to be exempted.

Workplace issues

REFERENCE TABLES 7-8a.

- The vast majority of respondents (97.5 percent) said it is important that workers have a smoke-free work environment. More than eight in 10 respondents said it is very important (84.4 percent).
- Two in three respondents said that work environments are better since the ordinance took effect (65.8 percent).

Restaurants that DO NOT serve alcohol

REFERENCE TABLES 9-13.

- Nearly one in two respondents said they eat at restaurants that DO NOT serve alcohol at least once a week (46.6 percent).
- Since the ordinance took effect, three in four respondents said they eat at restaurants that DO NOT serve alcohol about the same as before (74.2 percent). Two in 10 (19.3 percent) eat more often.
- More than two in three respondents said their experience of eating at restaurants that DO NOT serve alcohol is more enjoyable since the restaurants became smoke-free (67.7 percent).
- The vast majority of respondents (92.4 percent) said that since restaurants that DO NOT serve alcohol went smoke-free, they had not traveled outside the Fargo/Moorhead area specifically to eat at a restaurant that allowed smoking.
- Respondents were somewhat indecisive when evaluating the effect on business since
 restaurants that DO NOT serve alcohol went smoke-free. Approximately four in 10 respondents
 said the ordinance had helped or had no impact on business (39.3 percent) and a similar
 proportion of respondents (39.1 percent) said it was too early to tell. Less than two in 10
 respondents said the ordinance had hurt business (15.0 percent).

Restaurants that DO serve alcohol

REFERENCE TABLES 14-18.

- More than one in four respondents said they eat at restaurants that DO serve alcohol at least once a week (26.9 percent).
- Since the ordinance went into effect, more than three in four respondents said they eat at restaurants that DO serve alcohol about the same as before (78.1). Nearly two in 10 eat more often (16.5 percent).

- Nearly two in three respondents (64.7 percent) said their experience of eating at restaurants that DO serve alcohol is more enjoyable since the restaurants became smoke-free.
- An overwhelming majority of respondents said that since restaurants that DO serve alcohol went smoke-free, they have not traveled outside of the Fargo/Moorhead area specifically to eat at a restaurant that allows smoking (95.5 percent).
- Respondents had differing opinions when asked what the effect of a smoke-free ordinance was
 on restaurants that DO serve alcohol. Nearly three in 10 said the ordinance had either helped or
 had no impact on business (29.1 percent). In contrast, approximately two in 10 said the
 ordinance had hurt business (20.7 percent). More than four in 10 respondents said it was too
 early to tell (44.9 percent).

Bars or cocktail lounges

REFERENCE TABLES 19-21.

- One in two respondents (51.4 percent) said they go to bars or cocktail lounges in Fargo/Moorhead, at most, once or twice a month. Approximately one in 10 respondents go to bars or cocktail lounges at least once a week (10.6 percent). Nearly four in 10 respondents said they never go to bars or cocktail lounges (38.1 percent).
- Of respondents who go to bars or cocktail lounges, compared to before the smoke-free ordinance took effect, most go to bars or cocktail lounges about the same as before (80.7 percent). More than one in 10 respondents (13.5 percent) said they go less often.
- Respondents were mixed in their opinions regarding the effect on business for bars and cocktail lounges since the smoke-free ordinance took effect. More than one in three said the ordinance had either helped or had no impact on business (36.4 percent). Nearly four in 10 said it was too early to tell what the effects of the ordinance would be (38.6 percent). Nearly two in 10 said the ordinance had hurt business (15.7 percent).

Secondhand smoke issues

REFERENCE TABLES 22-25.

- An overwhelming majority of respondents said that secondhand smoke is a health hazard (97.8 percent).
 More than two in three respondents think it is a serious health hazard (67.2 percent).
- Most respondents said the smoke-free ordinance will reduce residents' exposure to secondhand smoke (86.1 percent).
- Most respondents said that being around secondhand smoke bothers them (84.1 percent); one in two respondents said it bothers them a lot (50.8 percent).
- The majority of respondents (85.0 percent) said the ordinance has been good public policy for Moorhead.

Demographic characteristics

REFERENCE TABLES 26-34.

- Respondents were evenly distributed among age categories. Approximately one in five were between 18 to 34 (19.1 percent), 35 and 44 (19.2 percent), 45 to 54 (20.3 percent), 55 to 64 (18.9 percent), and 65 or older (21.4 percent).
- Regarding social issues, more than one in three respondents considered themselves to be moderate (34.7 percent). Four in 10 respondents said they were somewhat or very conservative (40.2 percent).
- Nearly three in 10 respondents said their annual household income before taxes was more than \$60,000 (29.4 percent).
- The majority of respondents (85.2 percent) had at least some college or technical school. More than four in 10 had at least a bachelor's degree (43.3 percent).
- More than half of respondents were employed full-time (56.1 percent); more than one-fourth were retired (26.7 percent).
- More than one in three respondents said they had children younger than 18 living in their household (36.4 percent).
- Two in three respondents were female (65.6 percent).
- Less than two in 10 respondents (14.2 percent) said they smoked or used tobacco products; nearly one in 10 (8.6 percent) smoked or used tobacco regularly.
- More than one in three respondents who smoke or use tobacco products said the smoke-free ordinance has caused them to think about stopping or reducing smoking (35.3 percent).
