- 1. The minutes from November 8, 2011 meeting were approved.
- 2. Kevin Brooks, English Department Chair, met to discuss State Board Policy 402.1.2. According to Brooks' memo, "effective Fall 2012, the following placement scores are required for admission to English 110. Students with <u>ACT English subtest</u> [emphasis added] scores of 14-17 or approved equivalents may take ENGL 110 if co-enrolled in a developmental English course when a co-enrollment option is made available by the student's home campus." This means NDSU must change its present General Education Administrative Policy 11 which currently states, "Students may receive placement credit for ENGL 110 based on <u>composite</u> [emphasis added] ACT score and satisfactory performance in ENGL 120 or equivalent."

The English Department suggests the policy be changed as follows:

Students with an ACT English subset score of 18 or above (or approved equivalents) may take ENGL 120. Students who complete English 120 with a C or higher will receive credit for English 110 with a passing grade (P). Students with **ACT English subtest scores** of 14-17 or approved equivalents must take ENGL 110 and co-enroll in English 100 [a 1 credit course that the English department is developing and moving through the approval system]. Students with an ACT English subset score below 14 must complete a developmental course at another institution before enrolling in English 110 at NDSU.

During the discussion, it became apparent that present SBHE guidelines did not provide cut scores for the equivalent placement tests for students who scored less than 14 on the ACT English subset. We will need that information to actually implement this policy.

Harrold moved and Ingalls seconded to approve the suggestion from the English Department in principle and that Brooks and Peterson should work with Registration and Records to draft a policy to implement these changes. The motion was approved.

- 4. Char, Larry, and RaNelle reported on the work of the Core Undergraduate Learning Experiences team.
 - a. They are analyzing the results of the survey of alumni, employers, faculty, staff, and students conducted last fall. They will be making a report to the campus on the survey data and other information in April. They expect to bring learning outcomes to the Faculty Senate next fall. Based on those outcomes, they will develop alternative models for the campus to discuss. They hope to have a final model ready for the Faculty Senate by the fall of 2014.
 - b. CULE sees their role as consulting physicians who are gathering data about the symptoms manifested by our GE patient. They interpret the data, rather than being driven by it. As consulting physicians, they will make recommendations to the Faculty Senate who will decide on our course of treatment.
 - c. There were 1322 responses. The response rate by group varied from 24% for faculty to 3% for students.
 - d. Some preliminary conclusions are:
 - i. Faculty and staff are more critical of present student performance and have higher standards for the future.
 - ii. All groups expect every outcome to be more important in the future.
 - iii. Understanding literature and the arts and reading and speaking a second language are rated as the least important outcomes by every group.
 - iv. In terms of future importance, writing and speaking clearly were rated as the top two by all groups. Working as a team member was in the top four for everyone except faculty. Thinking creatively and innovatively was among the top six for all groups. Thinking critically was in the top seven for all groups.

- v. In the open-ended comments, both employers and alumni advocated internships (early on), career-planning, and financial literacy as areas they would like to see included.
- vi. Both "working effectively with people from different backgrounds and cultures" and "understanding the viewpoints of societies other than the United States and Europe" were outcomes where all respondents saw a large gap between future importance and present level of student preparation.
- e. This sparked a general discussion about the importance of some learning outcomes such as adaptability and life-long learning which are crucial, but can be difficult to assess.
