- 1. We began by welcoming our new representatives who were able to attend: Cole Davidson, Cassie Hillen, Nathan Todd, and Brent Young
- 2. The minutes from the May 7, 2012 meeting were approved.
- 3. We agreed to establish the following standing subcommittees:
  - a. Humanities, Fine Arts, Communications –Gary, Larry, Marion
  - b. Science and Technology, Wellness Brent, Char, Nathan
  - c. Social and Behavioral Sciences, Quantitative Reasoning—Linda, Mary, Tom
  - d. Student Petitions— Cassie, Cole, Darshi
- 4. Tom moved and Cassie seconded a motion to approve the revisions to the North Dakota General Education Council Constitution and recommend them to the Faculty Senate. The motion passed unanimously.
- 5. We discussed having GE representatives for the University Assessment Committee and CULE given the fact that Larry now represents both GE and Assessment on those two committees. Mary volunteered to serve as the General Education representative to the Assessment Committee.
- 6. Larry gave a brief update on the WICHE Interstate Passport Initiative (transfer agreement) from the NDUS office. Provost Rafert has signed and returned the agreement for NDSU. We discussed the potential implementation difficulties because we are still working on creating a smooth connection between a learning outcomes model (WICHE) and our traditional course/credit model.
- 7. Larry noted that CULE (Core Undergraduate Learning Experiences) may ask GE to review capstone projects for accreditation report due next spring.

9.	Under New Business, Cole led a discussion regarding HUM/FA transfer credits. NDSU's current policy
	states that only three credits may be from the performance area. However, when the Registrar's
	Office receives GE courses classified as HUM/FA from other institutions, they have no controls in
	place to ensure that they are not counting more than three performance credits toward our
	HUM/FA requirement. We noted that currently there were only two art courses in the performance
	category. After discussing whether present performance course instructors should be consulted, we
	decided to have the Registration and Records staff use their own judgment, but to maintain the
	three credit limit on performance credits.

#### 3. Subcommittee Reports

The Committee approved the motion from Langley, seconded by Dowdell, to accept the
recommendation from the Social and Behavioral Sciences, Quantitative Reasoning
subcommittee (Linda, Mary, Tom) to recommend POLS 120: Terrorism (Outcomes 3 & 6) for
a five year renewal to the Faculty Senate. Members thanked Gary Totten for his good work
with this course.

- 4. Davidson asked the committee if Registration and Records should continue reviewing international student's transcripts and determine what will transfer and what won't or if it should be brought to the committee for them to decide. It was decided that Registration and Records will continue to handle these requests on a course by course basis and if they would like the committee's input they may bring to the meeting. Students also have the right to appeal the decision.
- 5. A discussion took place regarding where GE materials should be kept. Should they continue to be stored with Registration and Records or moved to the Institutional Repository in the Library? It was decided that the information will be moved from Blackboard into the Institutional Repository to allow easier access to the materials by students, faculty and staff.
- 6. The Committee discussed the "equivalent" GE courses that fall under GE Administrative Policy #6. We agreed they should be listed as "known equivalents" of GE courses and decided on a two stage process. Peterson will contact the departments to get their approval. Once that is secured, Registration and Records will list them with the other courses. Those courses are:
  - Policy 6A equivalents
    - MATH 147: Applied Calculus II
    - MATH 166 Calculus II
    - MATH –any class numbered at the 200 level or above
  - Policy 6B equivalents
    - CHEM 150: Principles of Chemistry I
    - CHEM 160 Principles of Chemistry I Lab
    - CHEM 151 Principles of Chemistry II
    - CHEM 161 Principles of Chemistry II Lab
    - PHYS 251: University Physics I
    - PHYS 251L University Physics I Lab
    - PHYS 252: University Physics II
    - PHYS 252L University Physics II Lab
- 7. The Committee discussed the spreadsheet on grades for GE courses from OIRA and the Provost's concern about the relatively high percentage of Ds, Fs, and Ws for some courses. Peterson noted that according to the Gardner Institute, a combined D, F, W rate of more than 30% is the generally accepted national standard for a "killer" course, and there were sixteen courses at 30% or higher.

Peterson contacted the six departments that have courses with a high total percentage and a high total number of those grades to solicit their ideas about this pattern. He is also forming an ad hoc committee to analyze these patterns and make recommendations to the Provost. The Committee discussed possible reasons for these high numbers and percentages. Wright noted that Nursing students might drop a course and then take it elsewhere and transfer it in. She also reported that some Nursing students actually take a harder science class (BIOL 220) because they lack the math background to get into CHEM 117. Linda asked if the date of withdrawal has anything to do with it. The last day to withdraw is earlier than it has been in the past, could this be affecting the grades?

3. Request to GE from the Core Undergraduate Learning Experiences (CULE): when CULE representatives met with the Deans and Directors on October 25 about the Six Core Questions to Frame Learning Outcomes for NDSU Undergraduate (attached), the Deans urged CULE to take more time in presenting these to the campus and to get help from two other committees: General Education and Academic Affairs. We were urged not to rush the GE revision process and to try to

enlist the other two committees to help us with presentations at college meetings, etc. during the spring.

- Peterson asked if committee members would be willing to attend these open forums and take notes or if they would be interested in presenting the information at some of the college meetings. Langley, Dowdell, and Totten volunteered to attend their own college meetings and take notes, Davidson said he would help.
- 4. Continued discussion about the problems with "equivalent" GE courses that fall under GE Administrative Policy #6. The beginning comments for each enumeration are from Cole Davidson. The comments that are italicized are from RaNelle Ingalls.
  - 1. It makes completion of GE requirements difficult to track when determining audit and graduation eligibility for missing GE requirements. (Hopefully, a veteran liaison would know how to skillfully apply this policy when doing an audit or determining graduation eligibility. But, this policy takes time to learn and understand; and it takes time and skill to apply the policy appropriately should there be missing GE requirements.)
  - 2. It makes completion GE requirements difficult to track when determining transfer equivalencies. (This really comes down to how much should be considered when determining a courses equivalency. I don't believe it is really the role or responsibility of a transfer evaluator to consider policy #6 when evaluating each individual course. However, if we are going to start listing known equivalencies, then it does become part of what they do because these courses are being publically displayed.)
  - 3. Students may not know if they should take GE equivalent courses.
  - 4. Students may not know which category upper level GE courses satisfy.
  - 5. In some instances, such as ENGL, the policy almost nullifies the GE approval process.
  - 6. There are many courses in our catalog that have a GE as a prerequisite, but have not been identified as equivalents will the GE committee identify all of these courses? (I don't believe the term "equivalents" is accurate, but rather it would be GE eligible. If you have an equivalent course it is either GE or it is not but there are several courses based on this policy that could make several courses eligible for GE.)
    - Totten asked if there are any other universities that have a model we could follow in regards to this.
    - Davidson noted that a course might not transfer in as "equivalent" to an NDSU course, but it still might be "comparable" to one of our GE courses.
    - The committee decided that Policy 6A should be reviewed to see if it is used when determining course equivalents. Maybe this part of the policy is not relevant and the policy can be revised to remove this section. Davidson will check with liaisons who evaluate transfer courses to see if they use this section. More discussion to follow at next meeting.

3. Continuing discussion about the problems with "equivalent" GE courses that fall under GE Administrative Policy #6. At our November 14 meeting the Committee "decided that Policy 6A should be reviewed to see if it is used when determining course equivalents. Maybe this part of the policy is not relevant and the policy can be revised to remove this section." Davidson discussed the option of removing 6A with RaNelle Ingalls and here are some of her thoughts:

While I can understand it may seem like a simple solution given that Upper Division Writing may be impacted by this policy, but the policy itself does have merit when it comes to clearing students for graduation requirements in categories that are deficient by just a few credits. The policy has been helpful in situations where students are missing a course or are short just a credit or two in a particular category; the liaison clearing the student has reviewed completed courses to see if the outstanding category could have been satisfied with pre-reqs. This is a

long-shot method, but it has saved students from being denied graduation and having to stay and complete one GE course. Also, this has helped to reduce the number of petitions to the GE committee requesting exception because we have been able to use the policy rather than having the student petition and request exception. One example of this provided by a liaison was CHEM 240 and CHEM 260.

I believe the main use of this policy has been with the SPAN/FREN/GERM course: Students who have taken three years of HS language can place directly into SPAN 202 and get credit for this course as a HUM and a Diversity because the pre-req is SPAN 201 with these GE categories. I see this as an appropriate use of the policy that benefits the students within the context of the initial spirit of the policy.

I believe it is easier to state that the UDW must be satisfied with courses on the UDW list than to do away with a policy that is used sparingly but with purpose.

#### 4. Subcommittee Reports

- Science and Technology, Wellness--PHYS 220: Physics for Designers (Physical Science,
  Outcomes 5 & 6) Brent Young reported that this class has been approved by Academic
  Affairs, but was not forwarded to GE for approval. The subcommittee (Myhre and Young)
  motioned to approve it. Dowdell seconded the motion. Committee approved.
- Social and Behavioral Sciences, Quantitative Reasoning-- PHIL 257: Traditional Logic
  (Quantitative Reasoning, Outcomes 5 & 6) Dowdell moved for approval contingent on the
  instructor providing additional information linking student assignments to the outcomes of
  the course. Langley seconded it. Committee approved the motion contingent on receiving
  the information. Peterson asked for an email from Langley and Dowdell explaining exactly
  what additional information is needed so he can inform Dr. Flood, indicating committee
  approval is contingent his providing the additional material.
- 5. The Committee considered revisions to General Education Policy 12 submitted by Registration and Records (changes underlined).
  - A student who has completed a general education program in the United States or Canada consisting of a minimum of 36 semester credits at a regionally accredited institution and who transfers to NDSU or who pursues a second baccalaureate degree at NDSU is considered to have completed his or her lower-division general education requirements at NDSU. Transfer student coursework from outside the United States and Canada will be evaluated on a course by course basis.
  - According to Cole, who cannot be here: "Our office has another suggested policy revision in regards to GE policy 12. After the committee gave R&R the blessing to waive the UDW requirement for students who already possess a baccalaureate degree (provided it is not a program requirement), there was some concern about insuring that students from countries other than the United States and Canada were not granted the same waiver. Thus, the attached document contains revisions to policy 12, which insure this will not happen."
  - "If you need rationale beyond what I have already provided for the policy 12 proposed revision please let me know and I would be happy to send something. Also, our office feels that sending this policy revision through faculty senate shouldn't be necessary as the policy itself isn't

changing, but simply being clarified. If the committee feels the need for approval through faculty senate, we certainly understand."

#### 3. Subcommittee Reports

- The Social and Behavioral Sciences, Quantitative Reasoning Subcommittee agreed that the revisions made by Dr. Flood for PHIL 257: Traditional Logic met their requests.
- 4. Members re-considered the tabled revisions to General Education Policy 12
  - The revisions were tabled on March 27 for two reasons:
    - Committee members wanted to know if this was a change in procedure rather than policy and therefore does not belong in policy.
    - Committee members were uncertain about why Canada was included. Do all Canadian institutions have similar GE requirements at U.S. ones do? Does Canada have a similar accreditation system?
  - The revisions submitted by Registration and Records were:
    - A student who has completed a general education program in the United States or Canada consisting of a minimum of 36 semester credits at a regionally accredited institution and who transfers to NDSU or who pursues a second baccalaureate degree at NDSU is considered to have completed his or her lower-division general education requirements at NDSU. Transfer student coursework from outside the United States and Canada will be evaluated on a course by course basis.
  - Davidson's message explaining these changes for the March 27 meeting stated:
    - "Our office has another suggested policy revision in regards to GE policy 12. After the committee gave R&R the blessing to waive the UDW requirement for students who already possess a baccalaureate degree (provided it is not a program requirement), there was some concern about insuring that students from countries other than the United States and Canada were not granted the same waiver. Thus, the attached document contains revisions to policy 12, which insure this will not happen."
    - "If you need rationale beyond what I have already provided for the policy 12
      proposed revisions please let me know and I would be happy to send
      something. Also, our office feels that sending this policy revision through faculty
      senate shouldn't be necessary as the policy itself isn't changing, but simply being
      clarified. If the committee feels the need for approval through faculty senate, we
      certainly understand."
  - Davidson stated that this policy revision more closely aligns the language of the policy with the actual practices in Registrar's office for reviewing and approving Gen Ed Courses for transfer students from different countries.
  - Davidson made a motion to approve this revision and Wright seconded it. Committee approved.
  - Peterson asked if this revision should be brought to the Faculty Senate in the fall for a vote
    or for information. It was decided that it should be sent forward for their vote and have
    Davidson present to discuss/explain why the revision is taking place and to answer any
    questions the Senate may have.

#### 5. New Business

- The revisions to NDUS Policy 403.7 Common General Education Requirement and Transfer
  of General Education Credits that were presented at the GE Summit in Devils Lake on April
  19 will be discussed campus-wide next fall. Because they are outcome-based, they would
  allow campuses to be more flexible in how they structure their general education programs.
- Peterson thanked Linda Langley and Mary Wright for their excellent service to the GE Committee.
