2. Meetings:

The Committee met 21 times during the 2004-2005 academic year: September 2, September 9, September 16, September 23, September 30, October 7, October 14, October 21, November 4, November 18, December 2, December 9, January 12, January 26, February 9, February 16, March 2, March 23, April 20, April 27, and May 4.

3. Policy and Procedure Changes:

Course Reviews:

The Committee completed rubrics for each of the seven Outcomes and added them to the course packages for new courses and five-year reviews. The rubrics are to be guidelines, rather than requirements and they are intended to communicate requirements of a course to all parties. The rubrics will be reviewed every five years.

The Committee revised the general education application forms for new courses and for the five year reviews. In addition, future course submissions may be done electronically and should be sent to the Registrar's office.

The Committee will send reminder letters to departments/programs about delinquent course submissions after three months. Reminder letters after six months will be copied to the appropriate Dean. Reminder letters after nine months will be copied to the appropriate Dean and the Provost.

The Committee agreed that courses using social sciences methods could meet Outcome 5.

Student Appeals:

On the basis of feedback from the Chairs and Heads of AFSNR and SM about substitution of courses for the laboratory co-requirement, the Committee agreed that students should complete co-requisite classes and labs and cross-discipline substitutions should be discouraged.

Program Issues:

The Committee recommended the Vertical Writing proposal from the English Department to the Senate. After much discussion for two years, the Committee agrees there is still need for greater clarification in at least five areas: 1) screening students for ENGL 110 or 120; 2) staffing upper level writing courses; 3) creating upper level writing courses; 4) coordinating and assessing these courses; and 5) evaluating the courses and overseeing the requirement.

The Committee supported a request from the Registrar's Office to explore using how NDSU might use a GE category code after the course number for GE courses. .

4. General Education Assessment: OAIR:

Dr. William Slanger, Director of the Office of Institutional Research and Analysis, presented the results of the Senior Results of Academic Profile (AP) administered Spring 2004. Eight self-selected volunteers were recruited from each of the eight colleges, with 36 actually completed the 3 hour exam. The average ACT composite of the sample was 25, and average GPA 3.32. Results show that NDSU scored higher in all eight of the normative categories than the 14 peer institutions used as comparisons. The mathematics scores at NDSU are impressive; writing and reading are the weakest.

General Education Integrated into the Major:

The Committee completed its review of Categories 9 (Computer Usage) and 10 (Communication Activities). The review for Category 11(Personal and Professional Ethics) was not completed for all colleges. The subcommittee working on Category 12 (Capstone Experience) developed a thorough matrix which the Committee was unable to completely review and discuss. The Committee agreed that after it has completed its review of the matrix, it should share the outcomes of the matrix at the Dean's and Director's meeting with Provost Schnell and with the different departments via the deans. When the review of all the categories is complete, the Committee will recommend dropping Category 9 to the Senate because it is so fully integrated into the curriculum.

Other:

The Committee completed sample questions for the web-based formative assessment of all of the Outcomes.

The Committee posted the assessment of General Education Outcomes in ADFH on its homepage as an example of good practice.

5. Student Petitions:

The Committee received 32 petitions from students for waivers or exemptions. It granted 26 and denied 6.

6. Course Reviews:

Five year reviews for 87 courses from 23 departments were due on December 15, 2004. On March 24, 2005 the Committee sent reminder memos to the 12 departments which had not submitted five year reviews due in December for 37 courses. Departments whose courses are not received by June 15, 2005 will receive a second reminder with a copy to the Dean. Departments whose courses are not received by September 15, 2005 will receive a third reminder with a copy to the Provost.

The General Education Committee completed action on 51 courses in 2004-2005. There are 13 courses still being evaluated or revised for further evaluation.

7. Unfinished Business:

There are seven major items of unfinished business.

- 1. Elect committee chair.
- Complete review of UNIV 189 as requested by the Provost. Approve and implement the revised draft of GDC questionnaire on Skills for Academic Success. Summarize findings from students, faculty, and institutional data. Discuss findings with Dr. Carolyn Schnell and Ms. Nancy Kaler.
- 3. Complete the review of the integrated general education and capstone reviews, in particular the Capstone Course Review Committee Draft Matrix/Spreadsheet.
- 4. Complete web-based formative assessment tool for General Education Outcomes.
- 5. Regularize the Committee's role in the GERTA review policy for procedures and general education
- 6. Evaluate the Committee structure and membership in the Senate Bylaws, in particular requiring a minimum of three years of service at NDSU for all members and changing status from non-voting to voting for the members of the Committee from the University Assessment Committee, the Vice President for Academic Affairs, and the University Registrar.
- 7. Implementing the Vertical Writing Requirement by establishing mechanisms for 1) creating and approving advanced level writing intensive courses and 2) continuing assessment and evaluation of the courses and modification of the requirement.
