1. 2010-2011 General Education Committee Members:

2. Meetings:

The Committee met six times during 2010-11: September 10, October 15, November 5, January 24, February 28, and March 28.

3. Policy and Procedure Changes:

The Committee gave the Registrar's Office permission to grant waivers to sophomores, juniors and seniors who have been disadvantaged by the withdrawal of BIOL 150, 150L, 151, and 151L from the list of approved General Education courses. Those courses are still listed on some curriculum guides as a General Education courses.

In order to select NDSU representatives to the North Dakota General Education Council, the Committee approved adding the following to its responsibilities under the Faculty Senate Bylaws: "Selecting two representatives and one alternate for the North Dakota General Education Council." The Committee's procedure will be that "the General Education Committee chair will serve as one representative. Committee members will select the other representative and the alternate from current members of the committee and members who have recently served on the committee."

4. Program Issues:

The Committee endorsed the North Dakota General Education Council Constitution and recommended its approval by the Faculty Senate.

5. Student Petitions:

The Committee received forty-nine petitions from students for substitutions, waivers or exemptions. It granted thirty-three and denied sixteen. The Office of Registration and Records granted administrative approval to thirty-one additional appeals and denied one.

6. Course Reviews:

The Committee began the fall semester with thirteen courses still in the process of being reviewed from previous years and one course overdue from previous years and not received. The Committee received four submissions for new courses and the one review that was overdue. The Committee completed action on four new courses and nine existing courses in 2010-2011. The Committee ended the year with four courses still in the process of being reviewed, three of which have been returned for additional information.
